Registration fees are based on use of the vehicle. Mobile Home Toters must be registered at the "fully equipped for service" weight. Changing from MOBILE HOME TOTER to ROAD TRACTOR during the registration year will result in an increase of registration fees. There is no credit or refund of fees to change from ROAD TRACTOR to MOBILE HOME TOTER during the registration year.
