**Division 74 - Triple Trailer Combinations:**

Restricted on the Holidays shown above on those routes shown as Holiday or Holiday & Weekend restricted on Route Map 5.

**Division 75 - Mobile Homes and Modular Units exceeding 8'6" in Width\*\*:**

Restricted on the Holidays shown on above except:

- Operations may recommence on Green Routes on Route Map 2, at 12:01AM on the first business day, **(Monday after the Thanksgiving holiday)** as shown above, following the observed holiday when width is not in excess of 10 feet AND the outermost extremities are illuminated by lamps or markers as described by the requirements of ORS Chapter 816.

**Division 76 - Towed Units exceeding 8'6" in Width or when Towing a Combination of Vehicles:**

Restricted on the Holidays shown above except:

- This rule does not apply when the tow vehicle is performing the initial emergency removal of a disabled unit from the highway or when the disabled vehicle or combination of vehicles is operating under a rule or variance permit allowing movement prior to the emergency.

**Division 78 - Long Longs, poles and pilings exceeding 105' in overall combination length:**

Restricted on the Holidays shown above.

**Division 82 - Non-Divisible Loads exceeding 8'6" in Width\*\*:**

Restricted on the Holidays shown above except:

- Operations may recommence:
  - ◆ on Interstate Highways at 12:01AM on the first business day, **(Monday after the Thanksgiving holiday)** as shown above, following the observed holiday when width is not in excess of 12 feet;
  - ◆ on Green Routes on Route Map 2, at 12:01AM on the first business day, as shown above, following the observed holiday when width is not in excess of 10 feet;
  - ◆ AND the outermost extremities are illuminated by lamps or markers as described in ORS Chapter 816.

**\*\*Exceptions to these Holiday travel restrictions are shown on Attachment H but may be limited to specific days and highways. The exceptions apply to Division 75, Division 82 and certain Division 76 movements only and became effective 11-15-2006. Read the exceptions carefully.**
