SPEAKER PROFILES



Chief Daniel G. Sharp, Chief of Police, Oro Valley Arizona

Daniel G. Sharp has served as Chief of Police for the Town of Oro Valley since January 2000. Prior to his appointment as Chief, Chief Sharp spent over twenty-one years with the Tucson Police Department, working in virtually every area of the department.

Chief Sharp has served as an adjunct faculty member for Law Enforcement Programs at Pima Community College and as an adjunct lecturer at the University of Arizona. He is routinely requested to lecture on public policy related to Community Policing and Ethics.

Chief Sharp holds a Masters in Educational Leadership and is a graduate of the 190th Session of the FBI National Academy.

In 2014 he was awarded the prestigious J. Stannard Baker Award for 'outstanding lifetime contributions to highway safety', and was the 2013 Greater Oro Valley Chamber of Commerce Legacy Award recipient.

He is a member of the International Association of Chiefs of Police, appointed by the President of the IACP as a member of the IACP Highway Safety committee, as well as the Chairman of Traffic Incident Management Subcommittee, the Police Executive Research Forum, the FBI Law Enforcement Executive Development Association, the HIDTA Management Subcommittee, Arizona Association of Chiefs of Police, and the FBI National Academy Associates.

Additionally, Chief Sharp is a member of the Arizona Criminal Justice Commission, is currently the vice-chairman of the Arizona Automobile Theft Authority Board and the chairman of the Pima County Wireless Integrated Network Board of Directors.

Chief Sharp is currently serving as the Oro Valley Interim Town Manager, a position he has held since June 2016.



Shailen Bhatt, Executive Director, Colorado DOT

Shailen P. Bhatt serves as the Executive Director for the Colorado Department of Transportation (CDOT), where he is charged with leading the department in planning for and addressing Colorado's transportation needs. Bhatt oversees 3,300 employees statewide and an annual budget of approximately \$1.4 billion, guiding an organization committed to becoming the best DOT in the country for all our customers.

During his tenure, CDOT has launched the Road X program which is focused on deploying innovative technology solutions such as connected vehicles and teaming with the private sector to shape our transportation future.

Prior to this appointment, he served as the Cabinet Secretary for the Delaware Department of Transportation. He also served as an Associate Administrator at the Federal Highway Administration (FHWA).

Chief Henry Clemmensen (Ret), Palatine Rural Fire Protection District

Chief Clemmensen began his fire service career in 1973 as a paid-on-call firefighter after serving in the US Army, 82nd Airborne Division. In 1977, he was hired by the Hoffman Estates Fire Department as a full-time firefighter/paramedic and was promoted through the ranks to Fire Marshal / Assistant Fire Chief. Hank also severed as the Chief Administrator of the Hoffman Estates Code Enforcement Department.

From 2001 until the end of 2016, Chief Clemmensen severed as Fire Chief for the Palatine Rural Fire Protection District. Chief Clemmensen served as President of Illinois MABAS Division I from 2005 to 2007, President of the IAFC Great Lakes Division from 2007 to 2009, and finally as President & Chairman of the Board for the International Association of Fire Chiefs (IAFC) in 2013 - 2014. Since his retirement from Palatine, Chief Clemmensen now works as a public safety consultant with some local and national companies.

Chief Clemmensen holds a Bachelor of Science Degree from Northern Illinois University and graduate studies in Public Administration through Northern Illinois University. He is also a commercial pilot/Flight Instructor for airplanes (land & seaplanes), rotorcraft-helicopters, and holds a Remote Pilot Certificate.



Colonel Tracy Trott, Tennessee Highway Patrol, Tennessee

Colonel Trott has served as a member of the THP since 1978. His experience includes seven years as a Road Trooper; six years as a Sergeant; and 14 years as a Troop Lieutenant, where he managed five counties in the Tri-Cities area. Trott served a five-month stint as Major in the Colonel's office, before being promoted to Lieutenant Colonel in August of 2006. He was appointed Colonel in September 2010.

Leading the list of his accomplishments, include a two-time honor (1983-84) as one of the top 10 troopers in DUI Enforcement in Tennessee; a certification as a police instructor by the POST Commission; a graduate of the Tennessee Government Executive Institute (2006) and selection into the Tennessee Law Enforcement Executive Development FBI program (2007). He was selected by the Tennessee Chapter of MADD to receive the 2015 Campaign to Eliminate Drunk Driving Award for his efforts to reduce impaired driving. Recently, the American Association of Motor Vehicles Administration presented him with the prestigious Martha Irwin Lifetime Achievement Award in honor of his successful career in public safety. He also received the 2016 Lead by Example Award from the Tennessee Government Executive Institute. Colonel Trott served as the Southern Region Chair for the IACP Division of State & Provincial Police until being elected to the position of 2nd Vice Chair for the division in 2012. At the conclusion of his 2 year term, he was sworn in as the 1st Vice Chair in October of 2014. This October, he was sworn in as the General Chair representing all state police organizations and provincial departments in the United States, Canada and Puerto Rico.

A native of Randolph, Maine, Trott earned an Associate's Degree in Law Enforcement, a Bachelor's Degree in Criminal Justice and a Master's Degree in Criminology from ETSU. He is also a 1996 graduate of the Northwestern School of Police Staff and Command, and graduated from the FBI National Executive Institute in 2013. He began his law enforcement career as a police officer with the ETSU Police Department in 1976.

Colonel Trott is married and has two grown children. He resides in Rutherford County.


