Veterans Day 2005

A message from the Director

As we gather to observe Veterans Day 2005, we do so as citizens of a nation at war. While it has been called a Global War, it is in many ways as much a World War as any that has borne that name in the past.

We remember those veterans who were serving our nation at the U.S. Embassy in Tehran, Iran in November of 1979 when they were taken captive and held for 444 days.

We remember those veterans who were serving in the U.S. Embassy compound in Beirut, Lebanon where 63 people were killed.

We remember those veterans who later in 1983 were serving in Beirut and 241 of our service members were killed.

We remember those veterans who were serving in Madrid, Spain in 1985 and were targeted by a bomb at a local restaurant.

Also in 1985, we remember those veterans who were serving at Rhein-Main Air Base in Germany where a terrorist bomb killed 22.

All veterans remember when the attacks on our military and civilian citizens increased with the 1985 killing of an American on the Italian cruise ship Achille Lauro, the bombing of TWA Flight 840 killing four people in 1986 and the bombing of Pan Am Flight 103 over Lockerbie, Scotland killing 259 people in 1988.

In January 1993, there was an attack on CIA headquarters in Langley, Virginia, which killed two CIA agents. In February 1993, the first attack on the World Trade

Center in New York killing six and injuring over 1000.

In November 1995, veterans remember when a car bomb exploded in Riyadh, Saudi Arabia killing seven U.S. service members. In 1996, the Khobar Towers were bombed in Dhahran, Saudi Arabia killing 19 and injuring over 500.

U.S. embassies in Kenya and Tanzania have been attacked killing 224 people. In October 2000, veterans remember the attack on the *USS Cole* while refueling in Aden, Yemen killing 17 U.S. Navy sailors.

We all remember September 11, 2001 and the terrorist attacks on the World Trade Center in New York City and continued terrorist attacks in Spain, England, Bali, the Philippines and so many more around the world.

On the front lines of this war and opposing this ongoing terrorist threat to our freedoms are America's finest. Our veterans of tomorrow, they deserve our support in this World War on Terrorism.

In addition, on Veterans Day 2005, we also honor those veterans of all wars who led the fight against dictators and tyrants around the world in defense of our freedom and the American way of life. Thank you all for your service to your communities, your state and our nation. May your service and sacrifice never be forgotten.

Governor Signs Veterans' Legislation



At a ceremony attended by several veterans, legislators and the Director of Veterans' Affairs Jim Willis, Governor Ted Kulongoski signed legislation to expand and enhance services offered to veterans including educational and veterans' home loan opportunities.

"Today we are here to honor the men and women who have served Oregon and our country through military service," said Governor Ted Kulongoski. "Too often, our soldiers are paid only in lip service, but with this package of legislation, we are making a commitment as a state to support those who risked their lives and their futures to defend us, our freedoms, and the principles that serve as the foundation of this great nation."

Senate Bill 223: Supports homeownership for Oregon veterans by increasing the maximum allowable veterans' home loan amount from 97 to 100 percent of the net appraised value, thus lowering up front costs to borrowers for a state veterans' home loan.

House Bill 2681: Requires school districts to issue high school diplomas to

honorably discharged veterans who did not complete high school because of wartime military service (minimum Armed Forces Vocational Aptitude Battery score, GED certificate, or post-secondary degree required). Makes future combat veterans eligible for the benefit.

House Bill 3504: Enhances the Oregon Education Aid program by increasing the state financial aid rate from \$50 to \$150 per month for full time attendance at an accredited school or college including vocational programs. Payments not to exceed the total number of months served in the Armed Forces or a total of 36 months, whichever is less.

Creates the Oregon Veterans' Emergency Financial Assistance Program within the Department of Veterans' Affairs to provide emergency financial assistance to veterans and their immediate families for needs that include but are not limited to emergency or temporary housing and related housing expenses, such as expenses for utilities, insurance, house repairs, rent assistance or food; emergency medical or dental expenses; emergency transportation; expenses related to starting a business, such as business licenses or occupational licenses; temporary income after military discharge; and legal assistance.

Establishes the Oregon Troops to Teachers program to pay tuition for those veterans who attend college and commit to teaching in Oregon.

Directs the Oregon Military Department to reimburse the cost of hunting and fishing licenses for active members of the U.S. Armed Forces and service members who retired from the U.S. Armed Forces within 12 months of making application.

Senate Bill 1100: Establishes a program within the Oregon Department of Veterans' Affairs to enhance and expand the services provided to veterans, their dependents, and survivors by county veterans' service officers. Services include assistance with filing for benefits earned as a result of military service and appealing any denial of veterans' benefits.

Creates the Oregon Military Emergency Financial Assistance program in the Oregon Military Department to provide hardship grants and loans to members and immediate family of Oregon National Guard members on active duty.

VA Reviewing Some PTSD Claims

Following an internal study that found regional inconsistencies in the way Post-Traumatic Stress Disorder (PTSD) claims were decided, the U.S. Department of Veterans Affairs (VA) is reviewing approximately 72,000 claims that were approved between 1999 and 2004 and were awarded full disability benefits for PTSD alone or in combination with other conditions.

Korean War Veteran Appointed to Governor's Advisory Committee

Korean War veteran Irv Fletcher was appointed by Governor Ted Kulongoski in August to serve on the Advisory Committee to the Director of the Oregon Department of Veterans' Affairs.

Honorably discharged in 1954 after serving in the U.S. Navy as a machinist aboard the *USS Corregidor (CVE-58)*, Fletcher will complete the remaining term of Committee member Hal Jordan who passed away in April. Fletcher's term on the nine-member Committee will run through December 2006.

"Having an experienced advocate like Irv serving on our advisory committee is a big plus for all Oregon veterans," said Jim Willis, the Director of the Department of Veterans' Affairs. "He brings with him integrity and commitment."

In 1973 the late-Governor Tom McCall became the first of seven Oregon chief executives to appoint Fletcher to serve on state government committees. As a lobbyist in the Oregon Legislature, Fletcher played a role in gaining legislative approval for the Labor Education and Research Center, which was established at University of Oregon in 1977.

Fletcher taught as a junior high teacher for 12 years in Klamath Falls, worked for the Department of Corrections, the Apprenticeship Information Center, and then served as president of the Oregon AFL-CIO from 1981 to 1999. Following his retirement, Fletcher renewed his teaching credentials and also has been very involved in the local Woodburn food bank delivering food to seniors. Irv and his wife Eva reside in Woodburn.

Oregon Veteran Receives National PVA Honors

The Paralyzed Veterans of America (PVA) has named F. David Parker of Portland, as the recipient of its 2005 Speedy Award in the member category. A former member of the Governor's Advisory Committee to the Director of Veterans' Affairs (VAAC), Parker received the award in August during PVA's 59th Annual Convention in Omaha, Nebraska.

The Speedy Award, PVA's highest honor, acknowledges the outstanding accomplishments of both PVA members and non-members in the field of paraplegia.

After 25 years of service to his country, Parker retired from the U.S. Marine Corps as a highly decorated officer. He served two tours in Vietnam, receiving numerous medals for his performance as well as a field commission. After Vietnam, Parker continued his service working with the Marine Corps Research and Development Center before receiving a disabling injury.

Parker has served over 20 years in a variety of leadership positions with the PVA, including national president (1989-1990).

"In receiving the Speedy Award, it gives me extreme pride to see my name added to a list of paralyzed heroes who, individually and collectively, have spent nearly 60 years making the Paralyzed Veterans of America the organization it is today," Parker said. "I have spent nearly 25 years performing a labor of love as a volunteer for PVA at the local and national levels. At every turn, I thank those who have provided me a support group as I overcame a spinal cord injury and went on to make my life a success."

His advocacy for the disabled and veteran communities is not limited to PVA. Parker also chaired the United Veterans Groups of Oregon and the VAAC. Parker worked extensively with the Oregon Legislature to help establish a state veterans' home and has worked tirelessly for the Disabled Volunteer Enforcement Program.

WWII, Korean War Veterans Receive Medals

It may have taken 60 years, but two Oregon veterans were presented with military service medals earned during service in Korea and in World War II. Russell Little, 86, of Salem and Lawrence Plaisance, 80, of Portland officially received their medals within a week of each other.

The ODVA's Deputy Director Paula Brown joined Bill Ward from Congresswoman Darlene Hooley's office, on September 26, in presenting Little with medals he earned years earlier as a Military Policeman along with service ribbons and sergeant's chevrons neatly arranged in a shadow box. Little's family including his wife, Edna, were among the crowd at the ceremony held on the Capitol steps in Salem.

"This is the first time I've received something for the work I did. It's something I'm very happy and proud to get and I thank all of you for being here," Little said.

In early October retired Portland police officer and veteran of both WWII and the

Korean War, Lawrence Plaisance received the Prisoner of War Medal and the Republic of Korea War Service Medal. A public ceremony was held at the Oregon Korean War Memorial in Wilsonville.

Plaisance participated in the invasion of Inchon, the recapture of Seoul, Korea, and two other major campaigns, and served in the U.S. Coast Guard during World War II in the European and Pacific theatres. Plaisance was among 100 troops captured in 1950 by the

Communist Chinese during the battle at the Chosin Reservoir. He was in captivity less than five days before he helped overpower and kill two guards, escaping to rejoin the famed 1st Marine Division.

Oregon Department of Veterans' Affairs Director Jim Willis coordinated and emceed the official medal presentation ceremony. Marine Corps Major Jason White presented the Prisoner of War Medal and the Republic of Korea War Service Medal.

Prescription Fraud Alert

The U.S. Department of Veterans Affairs (VA) has received several reports of veterans receiving calls from a company soliciting personal information such as social security and credit card numbers and falsely indicating that it is dispensing prescriptions to veterans for the VA.

Veterans have reported being contacted by callers claiming to be representatives of a company called Patient Care Group (PCG) indicating that veterans prescriptions will be dispensed through PCG as a result of a change to the VA's prescription program and that veterans need to provide a credit card number to ensure they continue to receive their medications.

According to the VA, it has not changed its process for receiving or dispensing prescription medications. If contacted by PCG, veterans are advised not to provide personal information. They are also advised to notify the Better Business Bureau of Oregon at 503-226-3981.

Veterans' Home Gets New Administrator



Distinguished Marines Postage Stamps



The U.S. Postal Service will release a long-awaited block of stamps titled ‘Distinguished Marines’ on November 10th, marking the 230th Anniversary of the U.S. Marine Corps. The stamps honor four Marine Corps heroes; Gunnery Sergeant John Basilone, Sergeant Major Daniel J. Daly, Lieutenant General John A. Lejeune and Lieutenant General Lewis B. (Chesty) Puller.

Gunnery Sergeant John Basilone, also known as “Manila John”, fought on Guadalcanal with the 1st Marine division in 1942 and was awarded the Medal of Honor for his heroism. Sergeant Major Dan Daly is one of only two Marines in history to receive the nations’ highest military award – the Medal of Honor – twice for separate acts of heroism. Lieutenant General Lejeune was the first Marine to command an Army division and later became Commandant of the Marine Corps. Lewis B. Puller known affectionately by all his fellow Marines as “Chesty”, was a battalion commander and regimental commander with the 1st Marine Division during World War II and the Korean War, rising to the grade of Lieutenant General in recognition of his service.

Each of the stamps will feature a picture of the respective hero and the military insignia of the military unit with which he was most identified.



Additional note: In addition the U.S. Mint is issuing the 2005 Marine Corps 230th Anniversary Silver dollar. This is the first time the U.S. has honored a branch of the military with a commemorative coin. Surcharges from the sale of 2005 Marine Corps Silver Dollars will be paid to the Marine Corps Heritage Foundation to help construct the National Museum of the Marine Corps in Quantico, Virginia. New Survivor Benefits Website

A new resource tool has been developed by the U.S. Department of Veterans Affairs (VA) to assist the survivors of military personnel who died either while on active duty or who died after leaving military service. The new tool is an Internet website which provides users with information about a wide range of benefits for the surviving spouse, dependent children, and dependent parents of deceased active-duty personnel and veterans.

The website is organized into two general categories – death in service and death after service. While most benefits are the same regardless of whether the service member or veteran died on active duty or during civilian life, the death in service portion does include additional information specific to death in service issues.

The site also contains information from and links to, other federal agencies and organizations such as the Department of Defense and the Social Security Administration that provide benefits and services to survivors and dependents.

The website is located at www.vba.va.gov/survivors/. If you have questions or plan to apply for benefits, you are encouraged to contact your local county veterans’ service office (see listing on page 11) or contact the Oregon Department of Veterans’ Affairs at 503-373-2085 or toll free at 1-800-692-9666. Application for veterans’ benefits is a complex process. The assistance of these professionals is provided at no cost.

Preserving Oregon’s History

Established in 1974, the Oregon Military Museum honors, showcases and preserves Oregon’s remarkable military history through its artifact, library and archive collections. Features include the 1911 Battery A Field Artillery Barn that houses a display of rare artillery, and a World War II Quonset Hut with displays relating to aviation.

Located on the grounds of Camp Withycombe in Clackamas, Oregon, the main museum building’s exhibits pay tribute to Oregon’s military heritage from the nineteenth century through the present with aircraft, artwork, equipage, insignia, ordnance, tanks, uniforms and vehicles.

Programs and services include a reference library, a technical library, and archived documents and photographs available for research by appointment. Museum staff provides tours, gallery talks, and in-house educational activities. Tours of the Restoration Shop are also available. The museum hosts special events such as an annual Living History Day and offers volunteer opportunities.

VA Overpayment Waivers

The U.S. Department of Veterans Affairs (VA) will make efforts to recover payments made to veterans, which are determined to be overpayments. Repayment of funds received can create a hardship on the veteran and the veteran’s family. Under certain circumstances, a waiver of the debt can be received from the VA.

Resources for Returning Service Members

If you have been deployed, or know someone who has, you are aware that both deployment and returning home from deployment can be stressful. Military OneSource was created to assist service members with those stresses. Military OneSource is a free information and referral service available 24 hours a day, seven-days-a-week. It is available worldwide to active duty, Reserve, and National Guard military members and their families and deployed civilians and their families.

Military OneSource provides information ranging from every day concerns to deployment/reintegration issues. If face-to-face counseling is needed, Military OneSource can provide a referral for six sessions per issue with professional civilian counselors at no cost to the military or family member (only available in the United States and Puerto Rico).

Legion of Honor Medals

U.S. veterans who participated in the liberation of France during World War II may be eligible for one of France's highest decorations, the Legion of Honor Medal. To apply for consideration for the medal, veterans must submit discharge documentation (Department of Defense Form DD-214) or similar documentation, which shows their participation in actions during one or more of the major campaigns. The campaigns under consideration are: Normandy, Southern France, Northern France and the Ardennes.

Previous military awards, such as the Medal of Honor, the Silver Star or Bronze Star, the Purple Heart or others, would be indicators of meritorious actions during these campaigns. Copies of these documents should be forwarded along with discharge documentation and a request for consideration for the French Legion of Honor to:

The Legion of Honor Committee in Paris, France, will review the applications. Based upon its members' approval, 100 medals will be bestowed upon U.S. veterans per year. Those selected will have the medal presented to them either at their homes or at a public ceremony during a patriotic holiday.

ODVA's Booth at State Fair Visited by Thousands

Each year, the Oregon Department of Veterans' Affairs (ODVA) employees staff a booth at the State Fair to provide information about veteran, survivor, and dependent benefits earned by veterans as a result of their military service. At the 2005 Oregon State

A big attraction at this year's booth was the Memorial Wall that contained photographs of Oregon's fallen military service members who served in Iraq and Afghanistan. The Memorial Wall was the idea and creation of several ODVA employees. Thousands of booth visitors paused and reflected on the

pictures surrounded by patriotic red, white and blue colors.

The State Fair is just one of many community outreach events and efforts where the Department consistently maintains a presence to provide Oregon's veterans and their families with important benefit information. ODVA's outreach include but are not limited to county fairs, senior expos, job fairs, veterans' stand-downs, mobilizations, demobilizations, family re-integration workshops, women veterans' conferences,

events held by and visits with Confederated Tribes, correction facility visits, in-home visits to housebound individuals, and veterans' organization events.

WWII Veterans Honored at 60th Commemoration of War's End

It was a time for remembrance with former comrades in arms as over 25,000 visitors gathered to remember the end of World War II at the Department of Defense's 60th Anniversary Committee's Commemoration at Fort Vancouver, August 26-28.

Among those gathered were survivors from Pearl Harbor and the Bataan Death March, soldiers who landed at Anzio and Normandy, the paratroopers, the pilots, air and ground crews, Marines who took Iwo Jima, and Merchant Mariners who manned the vital supply and troop ships. They were there to recall and to remember their buddies who did not come home. Everywhere people stopped and shook hands with the "Greatest Generation" and thanked them for their service.

Former Naval Reserve Ensign Larry Lydon, 84, of southwest Washington, wore the woolen naval officer's dress uniform he had worn aboard the *USS San Francisco* anchored at Pearl Harbor on Dec. 7, 1941. Lydon recalled how his crew, with no ammunition, boarded the *USS New Orleans* docked nearby.

"An officer on deck ordered us not to fire unless fired upon, but moments later another officer ran by yelling 'belay that order and fire at will,'" Lydon chuckled.

Former Army Sgt. Arthur Collins, 85, fought in the Battle of the Bulge. "It was cold and scary, but we worked together. It was war."

Dale Bowlin, 85, a former POW from Vancouver, agreed.

"If it wasn't for a German soldier who drug me into a building and later got me a doctor, I wouldn't be here today. They removed part of my leg to save my life," he said.

The U.S. Merchant Mariners were one of the larger veterans' groups at the event. They had many people approach their large Victory Ship display to ask questions.

"We were misunderstood," said Nelson Cauble, 78, of Roseburg. "We took the same oath as anyone who joined. We didn't get any respect for a long time, but that's changed. Generals Eisenhower and McArthur once said they wouldn't have had the men and supplies needed to win the war if it hadn't been for the Merchant Mariners."

Oregon Governor Ted Kulongoski, a U.S. Marine Corps veteran, said during a ceremony, before more than 2,500 people, that these Americans literally saved the world from tyranny and oppression. "The seeds of heroism were planted by you and grow. By whom much is sacrificed, much is owed. Our words of thanks are inadequate. You all deserve every honor and tribute this nation can bestow."

Presentations were made to one World War II representative from all the military services, including the Women's Army Corps, the WAVES (Women Accepted for Volunteer Emergency Services), and WASPs (Women's Airforce Service Pilots). A USO Show featuring the Navy Band Northwest and the *Liberty Belles*, a trio who sang songs from the 1940s, caused many older couples to sing along while smiling and holding hands.

Fee Waiver at State Parks for Veterans

Information provided by the Oregon State Parks Department

Oregon is home to hundreds of state parks, more than 50 with campgrounds. Starting on Veterans Day, November 11, 2005, veterans with service-connected disabilities can enjoy any one of them free of charge.

The Oregon Parks and Recreation Department will begin the service this year. Here are the details:

- Free state park camping and day-use entry year round starting November 11, 2005. This applies only to parks that are run by Oregon State Parks.
- Free state park camping applies to RV and tent sites only.
- You can camp in a state park for free for up to 5 days in a row, and up to 10 days per month.
- For a complete list of state parks, go online to www.oregonstateparks.org/ or call 1-800-551-6949, Monday-Friday, 8 a.m. to 5 p.m. and ask for a park guide.
- To make a campground reservation, call 1-800-452-5687. You can call to make reservations two days to nine months in advance. There is a fee to make a reservation (\$6 per reservation). Tell the reservation agent you are a veteran with a service-connected disability. You will be reminded to bring identification to the park when you check in.
- You don't always need a reservation (some state parks do not accept reservation requests), but it is a good idea to check if you're going to visit during a busy time of year or if you want a specific site.
- For day-use visits, contact staff when you enter the park if possible and obtain a pass for the day.

The Parks Department is designing a pass card system you can use to show you're eligible for free camping and day-use. Until the system is ready, other forms of identification that will be accepted include: disabled veteran's license plate, VA medical card or letter indicating your disability. When the new card system is ready, the Parks Department will make another announcement with details.



WWII Victory Ship Finds Permanent Home

In mid-September during a ceremony held in the lobby of the Oregon Veterans' Building at 700 Summer Street N.E. in Salem, Oregon Department of Veterans' Affairs (ODVA) Director Jim Willis accepted a model of the World War II Victory ship, the *S.S. Lane Victory* on behalf of the Department.

Andy Sorensen of Lebanon, Oregon, a Merchant Marine veteran who built and sailed on merchant marine ships during WWII, built the model using his own creativity and ingenuity. The *S.S. Lane Victory* joins a WWII Liberty ship model built and donated by Sorensen. The *S.S. Jeremiah O'Brien* has been on display in the lobby of the Veterans' Building for several months along with other Merchant Marine memorabilia.

Andy Sorensen passed away in March 2005 at the age of 89. His widow, Marian Sorensen presented the models to the Department for permanent display.

"They are fragile and I do not know what I would have done with them. Here, other people can see and enjoy them. This is a perfect home for them," Sorensen said. "I know that Andy would be pleased."
