Purpose of Notice

Oregon Housing and Community Services (OHCS) intends to adopt permanent amendments to the Oregon Administrative Rules for the Community Development Incentive Project Fund. The proposed amendments will revise the application and approval process for the fund and will eliminate a redundant rule.
