(First, Category III)	\$1,980 CIVIL PENALTY - OR - 12-DAY SUSPENSION <u>AGGRAVATION</u> Licensee was personally involved in the violation.

HOOD PIZZA & GRILL (L) 73285 E Highway 26 Rhododendron OR 97047 (03-38580-L)	OAR 845-007-0020 (2) - Licensee advertised reduced-price alcoholic beverages outside of the licensed premises (September 1, 2005). (Second, Category V)	LETTER OF REPRIMAND Note: Because Licensee has surrendered the liquor license, staff propose the Commission issue the Licensee a Letter of Reprimand. This reprimand will become a permanent part of the Licensee's Commission file and may be considered in any future application for a liquor license by the Licensee.

- AGGRAVATION
1. Permittee was previously warned about being under the influence of intoxicants while on duty (Violation Number One).
 2. Violation Number Two involved service to five visibly intoxicated patrons.

Note: Licensee received fast track tickets for violations one and four. Licensee paid the civil penalty for both violations on 10/25/05.

MITIGATION

Violations Number Two and Three will be charged at the first level because both violations were discovered concurrently.

Violation Number Three
OAR 845-006-0347 (2)(a) - Permittee

Slanaker permitted disorderly activity when she failed to prevent one patron from twice physically assaulting another patron (July 8, 2005).

Permittee Slanaker allowed an alcoholic liquor to be sold, dispensed, served and/or consumed after 2:30 a.m. (July 8, 2005).
