Committee members commented that physician/physician assistant teams do not always provide the requested information about the quantity and frequency of procedures performed.

ACTION PLAN: Modify the Practice Description to include columns to list the quantity and frequency that procedures are performed.

Committee members noted that some cardiology practices submit a list of procedures without requested supervision levels when submitting practice description requests. Members suggested that staff send the in-house approval list to these practices to use as a guideline when submitting practice descriptions.

ACTION PLAN: Send approval list used by staff to selected cardiology practices.

Use of Web Cameras in Physician Assistant/Supervising Physician Practice

EXHIBIT A

A Practice Description was submitted to the Board from a Planned Parenthood clinic in Grants Pass. The supervising physician for this practice description practices in Eugene. Since the clinic was unable to find a supervising physician in the local area, the physician assistant must travel to Eugene twice a month for her on site supervision which is required by OAR 847-050-0037(2)(d). The clinic has requested a modification to the requirement based on Planned Parenthood having a well defined protocol based practice and that the rural Grants Pass location has not been able to fill the position for seven months.

Dave Jones, PA-C, noted that there would be a positive fiscal impact to practitioners in rural areas if the administrative rule were changed to require 8 hours of supervision every month rather than 4 hours every two weeks. Committee members discussed the possibility of a temporary rule adoption.

It was moved and seconded that:

The Physician Assistant Committee recommends the Oregon Medical Board temporarily adopt and amend OAR 847-050-0037(2)(d) by replacing “a minimum of four hours of on-site supervision every two weeks” with “a

minimum of eight (8) hours of on-site supervision every month, or as approved by the Board.”

Physician Assistants Ordering Restraints

The Physician Assistant Committee discussed a recent question posed to the Oregon Medical Board regarding whether physician assistants should be allowed to order restraints for patients. Nathalie Johnson, MD, noted that all practitioners must follow the rules of institution when ordering restraints.

It was moved and seconded that:

The Physician Assistant Committee recommends the Oregon Medical Board add “Order Restraints” to the list of core privileges on the Practice Description.

ACTION PLAN: Add “Order Restraints” to the core list of privileges on the Practice Description.

Committee Reappointments – Ted Ruback, PA-C and Dave Jones, PA-C

Committee members recommend that the Oregon Medical Board reappoint Dave Jones, PA-C, and Ted Ruback, PA-C to the Physician Assistant Committee.

Review of Presentation to Board

Ted Ruback, PA-C, reviewed the scope of practice presentation that physician assistant members of the Committee gave to the Board at the April meeting. Mr. Ruback stated that physician assistant members would like to eventually propose a change in the scope of practice for physician assistants in Oregon. Nathalie Johnson, MD, suggested that a sub-committee create a more specific proposal for the Board to include rationale and numbers from other states (ratios and audits). Dr. Johnson noted that this may require a change in Oregon Revised Statute and may be a multi-year process. Kathleen Haley, JD, suggested that a representative from the insurance industry be included in the sub-committee.

Locum Tenens/Emeritus

EXHIBIT B

Committee members discussed the proposal drafted by OMB staff regarding a new process by which retired physician assistants could work in rotating assignments after retirement from active practice (see Exhibit B). It was noted that several physician assistants have inquired about this possibility.

Informed Consent

EXHIBIT C

At the last meeting of the Physician Assistant Advisory Committee, members proposed an addition to the practice description stating that as part of their practice, physician assistants obtain informed consent for procedures they are personally performing. Board Counsel, Warren Foote, suggested there are two possible interpretations of ORS 677.097, one of which precludes physician assistants from obtaining informed consent.

Dave Jones, PA-C, reported that he has been working with Marshall Coba, the Oregon Society of Physician Assistants (OSPA) lobbyist. Mr. Coba has is looking for a bill to which an amendment may be added to modify the language in ORS 677.097 (see Exhibit C).

Information Item: CME Rule Revision

EXHIBIT D

Ted Ruback, PA-C, stated that pre-approved courses from the American Academy of Physician Assistants needs to be added to the list of acceptable CME in this rule (see Exhibit D).

Personal History Question, Category II, Question 2

Committee members reviewed the proposed new language for Personal History Question Category II, Question 2, on the application for licensure.

Legislative Update – Kathleen Haley, JD

Kathleen Haley, JD, summarized legislation which is currently under consideration.

Other Business

Dave Jones, PA-C, reported that he had met with a representative from the Oregon Board of Radiologic Technology. This representative had noted that physician assistants can order and do initial interpretations of x-rays, however, they can not perform x-rays. Radiation Protective Services issues exemptions for practitioners to perform x-rays without a license. Mr. Jones suggested that an Oregon Administrative Rule could be changed to allow physician assistants the ability to obtain such a waiver.

OREGON ADMINISTRATIVE RULES
CHAPTER 847, DIVISION 050– OREGON MEDICAL BOARD
PROPOSED RULES CHANGES
TEMPORARY RULE ADOPTION – JULY 9, 2009

847-050-0037

Supervision

(1) The supervising physician is responsible for the direction and regular review of the medical services provided by the physician assistant.

(2) The type of supervision and maintenance of supervision provided for each physician assistant shall be described in the practice description and approved by the Board. The supervising physician shall provide for maintenance of verbal communication with the physician assistant at all times, whether the supervising physician and physician assistant practice in the same practice location or a practice location separate from each other, as described in the following:

(a) The practice is listed in the practice description of the physician assistant and is pre-approved by the Board.

(b) Practice locations, other than primary or secondary practice locations, such as schools, sporting events, health fairs and long term care facilities, are not required to be listed in the practice description of the physician assistant if the duties are the same as those listed in the practice description. The medical records for the patients seen at these additional practice locations will be held either at the supervising physician's primary practice location or the additional practice locations. The supervision of the physician assistant at locations other than the primary or secondary practice location shall be the same as for the primary or secondary practice location.

(c) In any instance where the supervising physician or designated agent is not providing direct or personal supervision of the physician assistant as defined in OAR 847-050-0010 (8)(a) and (c), the supervising physician or designated agent shall provide for the maintenance of direct, verbal communication by telephone, radio, radio telephone, television or similar means but is not required to be physically present at the practice site.

(d) The supervising physician or designated agent will provide a minimum of [~~four hours of on-site supervision every two weeks~~] **eight (8) hours of on-site supervision every month, or as approved by the Board.**

(e) The supervising physician or designated agent will provide chart review of a number or a percentage of the patients the physician assistant has seen during each month as stated in the practice description as approved by the Board.

(3) The degree of independent judgment that the physician assistant may exercise shall be in accordance with the Board approved practice description and supervision. The supervising physician may limit the degree of independent judgment that the physician assistant uses but may not extend it beyond the limits of the practice description.

(4) A physician who has restrictions upon or actions against their license may be subject to Board investigation prior to approval or may be denied approval as a supervising physician.

(5) The Board may defer taking action upon a request for approval as a supervising physician pending the outcome of the investigation of the physician for violations of ORS 677.010-.990.

**PROPOSAL FOR PROCESS OF APPROVING LOCUM TENENS/EMERITUS WORK BY RETIRED PHYSICIAN ASSISTANTS
FIRST DRAFT**

At its April meeting, Board members directed staff to develop a process by which a physician assistant who had retired from active permanent practice to work in temporary “locums” assignments or on a volunteer basis.

The OMB’s new computer system, TechMed, scheduled to be implemented this summer will allow a PA to hold an Emeritus license. A practice description would be required for any facility a PA wishes to volunteer on a regular basis.

Staff met to discuss the wish of the Committee/Board to create a way for recently retired PAs to do locum tenens or volunteer work after they retire from their regular practice. Since the Board’s definition of locum tenens requires that the practitioner lives out of state, it was decided to refer to this type of work by retired PAs as “rotating assignments.”

A PA normally has 3 months to submit a new practice description after the termination of his/her only or last supervisor. After 3 months they must submit reactivation paperwork if they wish to practice again. Physician Assistants who are retiring from regular practice but wish to continue with intermittent assignments would be asked to notify the Board of their intention to pursue temporary rotating assignments. With this notification from the PA, the Board could extend the 3 month grace period.

QUESTION TO THE COMMITTEE/BOARD: Should the 3 month “grace period” be extended for PAs who notify the Board of their intention to pursue rotating assignments, and if so, for how long?

COMMITTEE SUGGESTION: One year.

PAs would be asked to submit practice descriptions of for any proposed sites that they know they would be going to on a permanent but intermittent basis. With these practice descriptions on file, the PAs can keep Active status. The practice description form would need to be modified, adding a question about whether the practice is a rotating assignment.

PAs with a rotating assignment practice description would need to notify the Board when they actually work at any site that they have designated as a “rotating assignment” (similar to a physician’s notification of locum tenens assignments).

QUESTION TO THE COMMITTEE/BOARD: What is the minimum number of days per year or biennium that a PA must work in a rotating assignment in order to keep the practice description open?

COMMITTEE SUGGESTION: 30 days/year

If a PA or supervising physician reaches the 4 PA/supervising physician limit, staff can temporarily approve assignments in rural, underserved or FQHC locations prior to Committee/Board review. Practitioners in urban locations can not have the limit waived per statute.

Staff also discussed PAs moving to Emeritus status. This would be accomplished in the same way described above. The practice description form will also need a question regarding whether the PA is paid for the work performed under the practice description. Only those PAs in non-paid positions would qualify for the Emeritus status.

Proposed modification to ORS 677.097

677.097 Procedure to obtain informed consent of patient. (1) In order to obtain the informed consent of a patient, a physician, *or physician assistant who is performing the procedure*, or podiatric physician and surgeon shall explain the following:

- (a) In general terms the procedure or treatment to be undertaken;
- (b) That there may be alternative procedures or methods of treatment, if any; and
- (c) That there are risks, if any, to the procedure or treatment.

(2) After giving the explanation specified in subsection (1) of this section, the physician, *or physician assistant who is performing the procedure*, or podiatric physician and surgeon shall ask the patient if the patient wants a more detailed explanation. If the patient requests further explanation, the physician or podiatric physician and surgeon shall disclose in substantial detail the procedure, the viable alternatives and the material risks unless to do so would be materially detrimental to the patient. In determining that further explanation would be materially detrimental the physician or podiatric physician and surgeon shall give due consideration to the standards of practice of reasonable medical or podiatric practitioners in the same or a similar community under the same or similar circumstances.

847-008-0070

Continuing Medical Competency (Education)

(1) Licensees who wish to renew their active license must have demonstrated ongoing competency to practice medicine by one of the following methods:

(a) Ongoing participation in re-certification by an American Board of Medical Specialties (ABMS) board, the American Osteopathic Association's Bureau of Osteopathic Specialists (AOA-BOS), the National Commission on Certification of Physician Assistants (NCCPA), or the National Certification Commission for Acupuncture and Oriental Medicine (NCCAOM); or

(b) [~~3~~] 60 hours of American Medical Association (AMA) Category 1, [or] American Osteopathic Association (AOA) Category 1-A, or American Academy of Physician Assistants Category 1(pre-approved) continuing medical education (CME) per two calendar years relevant to the licensee's current medical practice[.] ; or

(c) 30 hours of NCCAOM courses per two calendar years relevant to the licensee's current practice.
