## Locum Tenens/Emeritus

## Exhibit A

Committee members reviewed and discussed the initial proposals created by staff (see Exhibit A) to accommodate physician assistants who have retired from active practice but still wish to work in temporary assignments. Ted Ruback, PA-C, noted that the proposal does not seem to include physician assistants with an Inactive license. Members discussed using the term "retired from clinical practice" in lieu of "retired."

Committee members agreed that during a rotating assignment the physician supervisor should be considered the primary supervising physician of the physician assistant, even if the physician assistant only works with the physician 30 days per year.

Committee members requested that staff draft initial language for Committee review regarding rules for rotating assignments.

## Informed Consent Update, Dave Jones, PA-C

Dave Jones, PA-C, reported that the Oregon Society of Physician Assistants hopes to present an amendment to Oregon Revised Statute 677.097 during the February

session. This amendment would allow a physician assistant who is performing a procedure to obtain informed consent for that procedure. Nathalie Johnson, MD, suggested that it may be easier to add the ability to obtain informed consent to the physician assistant section of the Oregon Revised Statutes.

Committee members agreed that the change in the Statutes should be accomplished as soon as possible.

## **Summary Sheets**

Committee members reviewed the summary sheets which have been used to present information during application and procedure review at Committee meetings, as well as the new practice description approval letter which has been in use since August. Ted Ruback, PA-C, commented that the use of the wording "supervision request" on the approval letter is a departure from language that has been used in the past, that "Practice Description request" or similar wording should be used in order to remain consistent with the form name.

Mr. Ruback, suggested that NCCPA certification be checked for all practice descriptions regardless of the requested prescription privilege level.

Staff reported that physician assistant specialties are now recorded for each practice description and will show on future summaries.

## **Final Review of Administrative Rules OAR 847-050-0037 Supervision**

## **Rule Changes – Informational Item Licensees with Mental Illness CME**

Committee members reviewed the proposed rule changes regarding licensees with mental illness and the new CME requirements for renewal of license. These rules were scheduled to be reviewed at the September 9, 2009 meeting of the Administrative Affairs Committee.

## **Legislative Update – Kathleen Haley, JD**

Kathleen Haley, JD, summarized recent legislation affecting the Oregon Medical Board.

## **Other Business**

The Board of Radiologic Technologies currently requires physician assistants to obtain a limited permit in order to take x-rays. Dave Jones, PA-C, has worked with the lobbyist for the Oregon Society of Physician Assistants on a bill in an attempt to work around this requirement. A waiver of the requirement can be applied for through Radiation Protective Services. Mr. Jones is not aware of any physician who has obtained this waiver.

### **15 Minute Public Comment Session**

Edwin Weih, PA-C, Oregon Society of Physician Assistants (OSPA), commented that the rule change regarding monthly supervision will be a positive change for rural practices, as physician assistants may be practicing in a different city than their supervising physician.

Mr. Weih inquired about polling physician assistants practicing in Oregon regarding the procedures they perform and at what level of supervision. Committee members informed Mr. Weih that this had been done in three specialties, orthopedics, anesthesiology and cardiology, and that the Committee is using the responses as an aid in achieving consistency in the approvals they recommend to the Board.

At its April meeting, Board members directed staff to develop a process by which a physician assistant who had retired from active permanent practice to work in temporary “locums” assignments or on a volunteer basis.

The OMB’s new computer system, TechMed, allows a PA to hold an Emeritus license. A practice description is required for any facility a PA wishes to volunteer on a regular basis.

Staff met to discuss how to implement a locums procedure for retired physician assistants and created a rough outline with questions for the Committee. Below are the concepts discussed by staff and input from the 6/11/09 Physician Assistant Committee meeting.

## **Physician Assistants Working in Locum Tenens Positions After Retirement from Regular Practice**

Since the Board’s definition of locum tenens requires that the practitioner live out of state, it was decided to refer to this type of work by retired PAs as “rotating assignments.”

A PA normally has 3 months to submit a new practice description after the termination of his/her only or last supervisor. After 3 months they must submit reactivation paperwork if they wish to practice again. For PAs who are retiring from regular practice but wish to continue with intermittent assignments we would ask that they notify the Board of their intention to pursue temporary rotating assignments. With this notification from the PA, the Board could extend the 3 month grace period.

6/11/09: COMMITTEE RECOMMENDATION: Extend the grace period to one year for PAs who notify the Board of their intention to pursue rotating assignments.

PAs would be asked to submit practice descriptions of for any proposed sites that they know they would be going to on a permanent but intermittent basis. This way, they can keep Active status. The practice description would need to be modified, adding a question about whether the practice is a rotating assignment.

PAs with this type of practice description would need to notify the Board of when they actually work at any site that they have designated as a “rotating assignment” (similar to physicians notification of locum tenens assignments).

6/11/09: COMMITTEE RECOMMENDATION: A physician assistant working under this scenario must work at least 30 days per year in order to continue to be eligible for Active status. The Board must be notified of the number of days worked.

If a PA or supervising physician reaches the 4 PA/supervising physician limit, staff can temporarily approve assignments in rural, underserved or FQHC locations prior to Committee/Board review. Practitioners in urban locations cannot have the limit waived per statute.

PAs wishing to change to Emeritus status would follow the same procedure as above. The practice description will also need a question regarding whether the PA is paid for the work performed under the practice description. Only those PAs in non-paid positions would qualify for the Emeritus status.

**OREGON ADMINISTRATIVE RULES**  
**CHAPTER 847, DIVISION 050– OREGON MEDICAL BOARD**  
**PROPOSED RULES CHANGES – OCTOBER 2009**  
**FINAL REVIEW BY THE BOARD**

**847-050-0037**

**Supervision**

(1) The supervising physician is responsible for the direction and regular review of the medical services provided by the physician assistant.

(2) The type of supervision and maintenance of supervision provided for each physician assistant shall be described in the practice description and approved by the Board. The supervising physician shall provide for maintenance of verbal communication with the physician assistant at all times, whether the supervising physician and physician assistant practice in the same practice location or a practice location separate from each other, as described in the following:

(a) The practice is listed in the practice description of the physician assistant and is pre-approved by the Board.

(b) Practice locations, other than primary or secondary practice locations, such as schools, sporting events, health fairs and long term care facilities, are not required to be listed in the practice description of the physician assistant if the duties are the same as those listed in the practice description. The medical records for the patients seen at these additional practice locations will be held either at the supervising physician's primary practice location or the additional practice locations. The supervision of the physician assistant at locations other than the primary or secondary practice location shall be the same as for the primary or secondary practice location.

(c) In any instance where the supervising physician or designated agent is not providing direct or personal supervision of the physician assistant as defined in OAR 847-050-0010 (8)(a) and (c), the supervising physician or designated agent shall provide for the maintenance of direct, verbal communication by telephone, radio, radio telephone, television or similar means but is not required to be physically present at the practice site.

(d) The supervising physician or designated agent will provide a minimum of [~~four hours of on-site supervision every two weeks~~] **eight (8) hours of on-site supervision every month, or as approved by the Board.**

(e) The supervising physician or designated agent will provide chart review of a number or a percentage of the patients the physician assistant has seen during each month as stated in the practice description as approved by the Board.

(3) The degree of independent judgment that the physician assistant may exercise shall be in accordance with the Board approved practice description and supervision. The supervising physician may limit the degree of independent judgment that the physician assistant uses but may not extend it beyond the limits of the practice description.

(4) A physician who has restrictions upon or actions against their license may be subject to Board investigation prior to approval or may be denied approval as a supervising physician.

(5) The Board may defer taking action upon a request for approval as a supervising physician pending the outcome of the investigation of the physician for violations of ORS 677.010-.990.
