Name: Rules Advisory Committee, APRN-RAC	Date: November 19, 2015
Short Description: Advisory body, called the Advanced Practice Registered Nurse- Rule Advisory Committee (APRN-RAC), established by the Oregon State Board of Nursing (Board) relevant to Administrative Rules for Advanced Practice Licensees.	
Purpose: The APRN-RAC is created for the purpose of obtaining public input on current administrative rules related to NP, CNS, and CRNA scope of practice, prescribing authority, educational program standards, and licensing requirements. The outcome is a recommendation for the Board to consider adopting, amending, or repealing administrative rules as deemed necessary by APRN-RAC.
