INSTRUCTIONS

1. TO APPLY FOR LOST TITLE ONLY.

Complete OWNER INFORMATION section. Owner and Co-owners signatures must be **notarized**.

All current Floating Home/Boathouse owners, as shown in State Marine Board records, must sign to verify title is lost.

If a security interest holder appears on the certificate of title, they must apply for the lost title. They must use a company stamp and then sign and specify position authorization. The law requires the State Marine Board to deliver the title to the first security holder

2. TO APPLY FOR LOST TITLE AND TO TRANSFER, REFINANCE OR CLEAR THE TITLE.

Complete the RELEASE OF INTEREST AND STATEMENT TITLE LOST section. **Owner and co-owner signatures must be notarized.**

All current Title owner(s) and Lienholders as shown must sign to verify title is lost and to release interest.

The Floating Home/Boathouse Registration Number must be on the form before signatures are notarized.*

If there is a change of ownership this form along with the title fee must be received by our office before 30 days from the date of purchase or there will be an additional \$25 penalty fee.
