



CONTESTANT/PROMOTER CONTRACT

The above parties agree to and with each other and the Oregon State Athletic Commission (“Commission”) to induce its acceptance of this contract as follows:

1. **Contestant** shall appear and enter into a _____ (Boxing/Mixed Martial Arts) contest at _____ (location) for the Promoter, at a weight not to exceed _____ pounds on the ____ day of _____, or on a date to be agreed upon no later than _____ weeks from the date set forth above, for _____ rounds to a decision.
2. **All contracts will be approved by the Commission Executive Director.** Disputes regarding the validity and enforceability of this contract shall be resolved by the Commission only if all contracts pertaining to the parties referred to in Paragraph 1 have been submitted to and approved by the Commission.
3. **Opponent** – Contestant’s opponent for this contest shall be _____. Contestant’s opponent shall compete at a weight that will not exceed _____ pounds.
4. **Compensation** – Promoter shall pay contestant the sum of \$ _____ for contestant’s performance of this contract.
5. **Other Compensation** – In addition to the above mentioned sum, the Promoter shall make the following compensation to the contestant (include all forms of compensation including reimbursement of expenses):

6. **Weigh In:** All weights shall be taken on official scales at a time and location to be set by the Commission. A Commission representative shall determine if the contestants make the required weight. If a contestant fails to make the weight agreed upon in this contract, but the parties nevertheless agree to the bout, a new weight shall be agreed upon and the contestant that fails to make the originally agreed upon weight shall forfeit 20% of his/her purse to their opponent.
7. Contestant agrees to appear when and as directed by the Promoter at all reasonable times for event promotional purposes unless scheduled appearances are agreed upon in this contract.
8. Scheduled appearances. Contestant agrees to appear at the following dates, times, and locations:

9. The Contestant understands that by participating in this contest that the Contestant is engaging in a potentially dangerous activity which subjects Contestant to a risk of severe injury or death. The Contestant, in full knowledge of the risks, nonetheless, agrees to enter into this agreement and hereby waives any claim that the Contestant or Contestant’s heirs may have against the Oregon State Athletic Commission or the State of Oregon as the result of any injury the Contestant may suffer as a result of Contestant’s participation in this contest.
10. The contest shall be conducted in accordance with the laws of the State of Oregon and in accordance with the statutes, rules, regulations and policies of the Oregon State Athletic Commission which are hereby made part of this agreement.
11. It is agreed that if Contestant, after signing this Agreement, enters into another contest prior to the one contracted for herein, without the consent of Promoter, Promoter shall have the option to rescind and cancel this agreement without liability.
12. Competition Gloves, approved by the Commission, for said contest shall be supplied by the Promoter.
13. The Contestant and Manager both agree to enter into this contest in good faith and agree that the contest’s outcome shall be determined solely by the honest competition and skills of the contestants. Manager and contestant represent that they know of no physical, legal, medical or mental impediment to contestant’s participation or licensure.
