Chairman Swayze called the meeting to order at 9:10 am.

Interim Oregon State Fire Marshall Jim Walker presented Multnomah County LEPC Charter to Chairman Swayze, discussed recent natural disasters that have occurred around the world stressing the importance of planning to the process of recovery, and the future of State funding of the LEPC/CR2K section of OSFM.

Chairman Swayze provided a status update of membership applications and the OSFM timeline for sending out warning letters to facilities that are not yet participating in the Multnomah County LEPC.

Bill Brauer from OSFM conducted overview training of Community Capability Assessments and Anatomy of an Incident with members present.

Chairman Swayze asked for volunteers to sign up for the Planning Sub-Committees.

Krista Fischer explained where to find the LEPC Toolkit and Community Capability Assessment documents on the OSFM website.

Terry Wolfe described how OSFM modified CCA's to better reflect lessons learned and community planning already established in the 25 years since Community Right to Know laws were first implemented, conducted overview training of Resource Assessments, Training Assessments, Public Outreach, and described how facilities interact with their LEPC Information Coordinator.

Members present agreed to conduct quarterly meetings at rotating locations in Multnomah County beginning with the June 17, 2011 meeting.

Chairman Swayze introduced a proposal to establish a Multnomah County LEPC website to be used for LEPC business separate from the business computer resources of the membership and solicited recommendations for implementation to be presented at the May 13, 2011 meeting.

Chairman Swayze adjourned the meeting at 11:15 am.
