WHEREAS, Zachary Kinzer, OTR/L is a licensee of the Oregon Occupational Therapy Licensing Board; and

WHEREAS, the Board has conducted an investigation and is prepared to issue a Notice of Proposed Disciplinary Action to the licensee alleging:

- (1) that the licensee Zachary Kinzer listed inaccurate times on his charting and billing sheets when listing times he was with patients; and
- (2) that the licensee Zachary Kinzer reported incorrect times on his office payroll reports; and

WHEREAS, the Board and the licensee wish to resolve and settle this matters without further proceedings; and

WHEREAS, the licensee being aware of his rights, hereby waives his right to further notice of the allegations, waives his right to a hearing and his right to review and agrees to the entry of this Consent Order:

FINDINGS OF FACT

- 1. Licensee is licensed as an occupational therapist and at all material times herein provided occupational therapy services at Corvallis Manor Nursing and Rehabilitation Center.
- 2. On January 14, 2004 there were seven instances where Zachary Kinzer reported inaccurate treatment minutes on his charting and billing sheets.
- 3. On January 15, 2004 a time study at the Corvallis Manor Nursing and Rehabilitation

1 Center found that there was one instance of inaccurate payroll reporting and five
2 instances of inaccurate charting and billing time spent with patients.

5 4. In the course of the investigation Zachary Kinzer admitted that he provided inaccurate
6 payroll times in order to make his productivity report look better.

10 CONCLUSION OF LAW

11 By not reporting correct treatment minutes on the charting and billing sheets and
12 inaccurately reporting payroll times, Zackary Kinzer violated OAR 339-010-0020(5)(a)
13 "intentionally making or filing a false or misleading report".
