Executive Session Convened 8:30 am.

The Board continued deliberation on complaints.

Public Session Convened 10:30am.

Dr. McGeorge moved, Mr. Liskey seconded, and the agenda was approved by unaminous vote. Mr. Liskey moved, Dr. McGeorge seconded, and the February 2011 and April 2012 meeting minutes were approved with corrections.

Chair Report: Mr. Reed reported the loss of his family's 14-year old Tschitzu and nine year-old Australian Shepherd, for whom veterinary costs in the last year totaled \$15,000.

Director Report: Ms. Makinen updated the Board on preparation for the upcoming Legislative session and budget preparation for the 2011-13 biennium.

Guests: Dr. Bill Young, practitioner from Eugene, spoke to the Board in opposition to the VCPR examination requirement, and clarification thereof provided to the public by the Director.

The Board discussed the temporary licensure statute and will seek input from OVMA concerning a possible legislative concept.

The Board reviewed an application for a permanent license from an individual requesting waiver of Internship requirements based on multiple externships. The Board concluded that the application did not warrant an exception.

Rulemaking

Dr. McGeorge moved, Dr. Maltman seconded and the Board voted unanimously to adopt rules to reauthorize the Board to license and regulate Certified Euthanasia Technicians.

To offset loss of revenue due to elimination of redundant examination fees, and in anticipation of increased enforcement expectations, Dr. McGeorge moved, Dr. Maltman seconded, and the Board voted unanimously to raise annual veterinary license fees to \$150 and CVT renewal fees to \$35.
