A former employee's complaint prompted an animal shelter to request an inspection. Staff inspected the premises and reviewed the shelter's euthanasia protocol and found the shelter to be substantially in compliance with the Veterinary Practice Act.
Two citizen complaints against staff were reviewed and dismissed.

Public Session Convened

Dr. Pielstick called the meeting to order at approximately 8:30 a.m. Dr. McConnell moved, Mr. Reed seconded, and the Board voted unanimously to approve the agenda and August meeting minutes.

RuleMaking

The Board welcomed Dr. Heidi Shafford, DVM, PhD, DACVA. Dr. Shafford provided followup on the Board's August discussion regarding minimum standards for pain management and presented information on her research of five other states' pain management rules. The Board reviewed its

proposed rule amendments. Dr. Lester moved, Dr. Acton seconded, and the Board voted unanimously to propose amendments to OAR 875-015-0030.

CVT duties relating to dentals: Mr. Reed moved, Mr. Liskey seconded and the Board voted to consider amendments to OAR 875-015-0050 and 875-030-0040/50.

Proposed amendments relating to the now defunct Euthanasia Task Force: Staff will bring further revisions to the next meeting.

Exam required prior to euthanasia: Mr. Liskey moved, Dr. McConnell seconded and the Board voted unanimously to amend OAR 875-015-0030 to require a minimal exam prior to administration of euthanasia and documentation of consent for the procedure. This amendment also clarifies that an exam must be done to establish a VCPR, and then each time thereafter if an animal presents with a new health problem. It retains the veterinarian's option of waiving exams after the initial VCPR exam except for new health problems.

The Board convened **executive session** to hear case 09-0024.

Public Session Reconvened

The Board reviewed and approved a student job-shadow program proposed by Dr. Giovanna Rosenlicht, OSU CVM.

The Board reviewed the OVMA jobs program and will make a decision prior to the next meeting.

The Board reviewed citizens' letters protesting VCPR exam requirements.

Director Makinen was asked to write a letter to Radiation Protection Services in support of their proposed rule amendments that would permit assessment of civil penalties for non-compliance, and requesting notification of veterinary practices found in noncompliance.
