STIPULATED AGREEMENT  
AND FINAL ORDER

The Oregon Physical Therapist Licensing Board (Board) is the state agency responsible for licensing and disciplining physical therapists and physical therapist assistants pursuant to ORS 688.140 and 688.160. Julie Moerke, PTA (Licensee) is licensed by the Board to practice as a physical therapist assistant (PTA) in Oregon.

On January 24, 2013, the Licensee was arrested and charged with driving under the influence and other related felony charges. The Board is prepared to issue a Notice of Proposed Disciplinary Action (Notice), but in lieu of issuing the Notice, the Board and Licensee agree to resolve the current issues through this Stipulated Agreement and Final Order (Stipulation) as follows:

1. Licensee may only work under the onsite supervision of a physical therapist;
2. Licensee must provide a copy of the Stipulation to her employer, and she must ensure that her employer provides the Board with written confirmation that the Stipulation was received and the required onsite supervision will be provided;
3. Licensee is required to provide the Board with the results of the court appearance scheduled for March 19, 2013, including but not limited to any stipulation, order or other document related to the initial arrest and/or court appearance;
4. Licensee is required to provide the Board with the results of any urinalysis that is ordered by the court or required by any rehabilitation program or the sober living program where Licensee will be residing; and

1 5. The Board and Licensee agree that this Stipulation shall be in effect until the Board
