The Oregon Physical Therapist Licensing Board (Board) is the state agency responsible for licensing and disciplining physical therapists and physical therapist assistants pursuant to ORS 688.160. Tyrone Trevor Teal, PT (Licensee) is licensed by the Board to practice as a physical therapist in Oregon. The Board issued an Emergency Suspension Order & Notice of Rights on April 8, 2002. On July 17, 2002 the Board filed a Notice of Proposed Disciplinary Action (Revocation of License) and on July 21, 2002 Licensee requested a hearing in which he asked that this proceeding be postponed until the criminal charges against him were resolved. On April 26, 2004 the Board filed an Amended Notice of Proposed Disciplinary Action (Revocation of License).

**STIPULATIONS**

1. Licensee is licensed by the Board to practice physical therapy having been issued license number 1629.
2. License provided physical therapy to patient CM on 19 occasions between December 10, 2001 and March 4, 2002. During that time Licensee had sexual intercourse with patient CM on three occasions in the clinic during treatment sessions. Licensee also had sexual contact with patient CM during numerous other treatment sessions.
3. Licensee provided physical therapy to patient TB on 9 occasions between January 28, 2002 and February 25, 2002. During those treatment sessions Licensee discussed with patient TB the subject of their having a sexual relationship. Within a few days after Licensee discharged patient TB from therapy he had sexual intercourse with her.
4. On November 10, 2003 Licensee was charged with four counts of harassment, a Class A Misdemeanor (ORS 166.065(4)), in Case No. 21-03-21266 in the Circuit Court of the State of Oregon for Lane County. Each charge related to a physical therapy patient (PF, SB, SD and CM, respectively). On November 12, 2003 Licensee pled guilty to and was convicted of the four counts of harassment, as charged.

5. Licensee stipulates that his actions described in paragraphs 2 and 3 constitute unprofessional conduct in violation of OAR 848-010-0050(1)(g),(h) and (i), which is a sanctionable violation pursuant to ORS 688.140(2)(d).
6. Licensee stipulates that he has been convicted of a crime that is a misdemeanor under the laws of this state, which is a sanctionable violation pursuant to ORS 688.140(2)(e).
7. Licensee stipulates to the revocation of his license as provided in this Stipulation and Final Order.
8. The Board and Licensee agree to resolve this matter through this Stipulation and Final Order.
9. Licensee is aware of his right to notice, to be represented by counsel, to a hearing where he could call witnesses and cross-examine witnesses called by the Board, and the Licensee hereby waives these rights and agrees to entry of this Stipulation and Final Order.

ORDER

IT IS HEREBY ORDERED:

1. The physical therapist license of Tyrone Trevor Teal is revoked, effective upon execution of this Stipulation and Final Order by the Board's representative. He may not apply for re-licensure from this Board for five years from the effective date of this Stipulation and Final Order.
