The Oregon Physical Therapist Licensing Board (Board) is the state agency responsible for licensing and disciplining physical therapists and physical therapist assistants pursuant to ORS 688.160. Bill Eberling, PT (Licensee) is licensed by the Board to practice as a physical therapist in Oregon. The Board has filed a Notice of Proposed Disciplinary Action for the Licensee's action based on Licensee's failure to maintain patient records.

STIPULATIONS

1. Licensee is licensed by the Board to practice physical therapy having been issued license number 1033.
2. License performed physical therapy on his wife, both in his clinic and at their home, from December 11, 2002 through December 7, 2003. During this time, Licensee failed to contemporaneously prepare and maintain written records.
3. Licensee stipulates that his actions constitute a violation of former OAR 848-040-0000 (1), renumbered 848-040-0110 (1), (2) and (3) which is a sanctionable violation pursuant to ORS 688.140(2)(d) and former OAR 848-010-0050(1)(o) renumbered 848-045-0020(2)(h).
4. Licensee stipulates to the assessment of a civil penalty of \$1,000. The Board stipulates to staying \$500 of the civil penalty if the Licensee does not violate any of the Board's statutes or administrative rules within one year of execution of this agreement.
5. Licensee understands and agrees that any further violations could result in further disciplinary action.
6. The Board and Licensee agree to resolve this matter through this Stipulation and Final Order.

7. Licensee is aware of his right to notice, to be represented by counsel, to a hearing where he could call witnesses and cross-examine witnesses called by the Board, and the Licensee hereby waives these rights and agrees to entry of this Stipulation and Final Order.

ORDER

IT IS HEREBY ORDERED:

The Licensee shall pay to the Board a civil penalty of \$500.00 by bank check. The civil penalty is due and payable upon execution of this Stipulation and Final Order by the Board's representative.
