	)	STIPULATED AGREEMENT
Licensee.	)	AND FINAL ORDER

The Oregon Physical Therapist Licensing Board (Board) is the state agency responsible for licensing and disciplining physical therapists and physical therapist assistants pursuant to ORS 688.140 and 688.160. Kim MacQuarrie, PTA (Licensee) is licensed by the Board to practice as a physical therapist assistant in Oregon. The Board issued a Notice of Proposed Disciplinary Action (Civil Penalty) on November 20, 2006. In lieu of proceeding to hearing, the Board and Licensee agree to resolve this case as follows:

1. Licensee stipulates that during times when she was delegated to be supervising physical therapist aides (aides), she allowed the aides to conduct spinal joint mobilization on patients in violation of OAR 848-020-0060(8) (January 2005).

2. Licensee stipulates that during times when she was delegated to be supervising the aides, she allowed aides to independently make subjective entries in patient records in violation of OAR 848-020-0060(10) (January 2005).

3. Licensee stipulates that during times when she was delegated to be supervising the aides, she allowed aides to perform a treatment or modality the first time that treatment or modality was done with several patients in violation of OAR 848-040-0145(1) (January 2005).

The above referenced facts and violations are grounds for discipline pursuant to ORS 688.140(2)(a).

4. Licensee stipulates to the Board imposing the following sanction:

a. Licensee is assessed a civil penalty in the amount of \$500.00.
