Licensee.	)	STIPULATION AND FINAL ORDER

The Oregon Physical Therapist Licensing Board (Board) is the state agency responsible for licensing and disciplining physical therapists and physical therapist assistants pursuant to ORS 688.160. William Burns, III, PT (Licensee) is licensed by the Board to practice as a physical therapist in Oregon. The Board is prepared to file a Notice of Proposed Disciplinary Action for the Licensee's action of practicing physical therapy with a lapsed license.

**STIPULATIONS**

1. Licensee stipulates that he renewed his 2009-2010 physical therapist license on April 21, 2009 and stipulates that his 2008-2009 physical therapist license lapsed on March 31, 2009.
2. Licensee stipulates that he worked as a physical therapist from April 1, 2009 through April 17, 2009. During that timeframe, Licensee practiced physical therapy after his license had lapsed and prior to its renewal.
3. Licensee stipulates that his action of practicing with a lapsed license constitute a violation of OAR 848-045-0020(2)(r).
4. Licensee stipulates to the assessment of a civil penalty and agrees to pay the civil penalty provided in this Stipulation and Final Order.
5. Licensee agrees and understands that any further violations could result in further disciplinary action.
6. The Board and Licensee agree to resolve this matter through this Stipulation and Final Order.
7. Licensee is aware of his right to notice, to be represented by counsel, to a hearing where he could call witnesses and cross-examine witnesses called by the Board, and Licensee hereby waives these rights and agrees to entry of this Stipulation and Final Order.

**ORDER**

IT IS HEREBY ORDERED:

The Licensee shall pay to the Board a civil penalty of \$100.00. The civil penalty is due and payable upon execution of this Stipulation and Final Order by the Board's representative.
