The Oregon Physical Therapist Licensing Board (Board) is the state agency responsible for licensing and disciplining physical therapists and physical therapist assistants pursuant to ORS 688.140 and ORS 688.160. Amy Keusink (Licensee) is licensed by the Board to practice as a physical therapist (PT) in Oregon.

The Board received a complaint regarding Licensee's practice and on April 5, 2010 the Board voted to issue an Interim Stipulated Agreement, in which the licensee agreed not to practice physical therapy during the pendency of the Board's investigation. Upon completion of the Board's investigation, for violations of ORS 688.140(2)(a) and OAR 848-045-0020(2)(f), the Board and Licensee agree to resolve all issues raised through this Stipulated Agreement and Final Order (Agreement) as follows:

1. The Board hereby terminates the Interim agreement. Licensee's license to practice is unrestricted.
2. Licensee agrees that beginning on the date this Agreement is executed by the Board, she will continue receiving psychological treatment weekly from current provider, or another Board approved provider, for a minimum of 3 months and up to 6 months, if recommended by the provider. Additionally, Licensee agrees to continue treatment beyond the 6 month timeframe as specified by the provider.

3. Licensee agrees that 6 months from the date this Agreement is executed by the Board she will provide the Board with a written self report and written report from her provider(s) regarding her treatment and progress.
4. Licensee agrees to undergo random urinalysis testing, at her own expense, for a period of 6 months from the date this Agreement is executed by the Board.
5. Licensee agrees to the assessment of a \$500 civil penalty which is stayed pending compliance with of all terms of this Agreement.

This Agreement is issued pursuant to ORS 688.140(1).
