)	STIPULATED AGREEMENT
Licensee)	AND FINAL ORDER

The Oregon Physical Therapist Licensing Board (Board) is the state agency responsible for licensing and disciplining physical therapists and physical therapist assistants pursuant to ORS 688.140 and 688.160. Mary Gorman, PT (Licensee) is licensed by the Board to practice as a physical therapist in Oregon. The Board is prepared to file a Notice of Proposed Disciplinary Action for the Licensee's action of failing to comply with the statutes and rules requiring completion of continuing education. The Board and Licensee agree to resolve the issues through this Stipulated Agreement and Final Order as follows:

STIPULATIONS

1. Licensee stipulates that she failed to complete the mandatory 1 hour online pain management educational course between January 1, 2006 and March 31, 2010, as required by law. Licensee's actions constitute a violation of OAR 848-035-0020(10) and 848-035-0035(1)(2) which is grounds for discipline pursuant to ORS 688.140(2)(a).
2. Licensee stipulates that on her 2010-2011 license renewal application, signed and dated by the Licensee on February 25, 2010, indicated that she had already completed the required pain management continuing education required to renew her license in violation of ORS 688.140(2)(c).
3. The Board assesses and Licensee stipulates to the assessment of a civil penalty of \$250 and Licensee agrees to pay the civil penalty within 30 days of the date that this order is executed on behalf of the Board.
4. The Board and Licensee agree to resolve this matter through this Stipulated Agreement and Final Order.
5. Licensee is aware of her right to notice, to be represented by counsel, to a hearing where she could call witnesses and cross-examine witnesses called by the Board, and the Licensee hereby waives these rights and agrees to entry of this Stipulated Agreement and Final Order.

ORDER

IT IS HEREBY ORDERED:

The Licensee shall pay to the Board a civil penalty of \$250. The civil penalty is due and payable within 30 days of the date that this Stipulated Agreement and Final Order is executed by the Board's representative.
