The Oregon Physical Therapist Licensing Board (Board) is the state agency responsible for licensing and disciplining physical therapists and physical therapist assistants pursuant to ORS 688.160. Michele M. Ross, PT (Licensee) is licensed by the Board to practice as a physical therapist in Oregon. The Board is prepared to file a Notice of Proposed Disciplinary Action for the Licensee's failure to perform reassessments of patients every 30 days which is a violation of former OAR 848-040-0040(1)(a) subsequently renumbered 848-040-0155(1)(a) and subject to discipline pursuant to former OAR 848-010-0050(1)(o) subsequently renumbered 848-045-0020(2)(h).

**STIPULATIONS**

1. Licensee is licensed by the Board to practice physical therapy having been issued license number 0251.
2. Several times in 1999 and 2000, during the time that Licensee was the only physical therapist working at Integrated Health and Wellness, she failed to perform required reassessments every thirty days.
3. Licensee stipulates that her actions constitute a violation of OAR 848-040-0040(1)(a) renumbered 848-040-0155(1)(a), which is a sanctionable violation pursuant to OAR 848-010-0050(1)(o) subsequently renumbered 848-045-0020(2).
4. Licensee stipulates to the assessment of a civil penalty of \$2,200.
5. Licensee understands and agrees that any further violations could result in further disciplinary action.
6. The Board and Licensee agree to resolve this matter through this Stipulation and Final Order.
7. Licensee is aware of her right to notice, to be represented by counsel, to a hearing where she could call witnesses and cross-examine witnesses called by the Board,

and the Licensee hereby waives these rights and agrees to entry of this Stipulation and Final Order.

ORDER

IT IS HEREBY ORDERED:

The Licensee shall pay to the Board a civil penalty of \$2,200.00 by bank check. The civil penalty is due and payable upon execution of this Stipulation and Final Order by the Board's representative.
