NEED FOR THE RULE(S):

To collect fees for the administration and tracking of Compact Privilege holders in Oregon.

DOCUMENTS RELIED UPON, AND WHERE THEY ARE AVAILABLE:

Physical Therapy Compact Administration Rules

FISCAL AND ECONOMIC IMPACT:

Minimal

COST OF COMPLIANCE:

Adoption of a Compact Privilege fee will have no fiscal impact on small businesses. The only impact will be to out of state licensees applying for the Compact Privilege to provide PT services in Oregon. This is an elected choice and

actually saves the individual dollars relative to making full application via the endorsement process.

As there is no fiscal impact to small businesses they were not involved in the development of these rules.

CHANGES TO RULE:

848-005-0020

Board Fees and Refunds ¶¶

(1) The following fees shall be paid to the Board:¶¶

(a) Physical Therapist or Physical Therapist Assistant Examination Application Fee of \$150.00, plus the actual cost to the Board of conducting a nationwide background check.¶¶

(b) Physical Therapist or Physical Therapist Assistant Endorsement Application Fee of \$150.00, plus the actual cost to the Board of conducting a nationwide background check.¶¶

(c) Oregon Compact Privilege Fee of \$50.00.¶¶

(d) Physical Therapist License Renewal Fee of \$170.00, plus the actual cost to the Board of conducting a workforce demographics survey as required by ORS 676.410(7).¶¶

(e) Physical Therapist Assistant License Renewal Fee of \$110.00, plus the actual cost to the Board of conducting a workforce demographics survey as required by ORS 676.410(7).¶¶

(f) Lapsed License Renewal Fee of \$50.00 for renewal applications postmarked or received by the Board after March 31st of an even numbered year.¶¶

(g) On-line renewal and application convenience fee not to exceed the actual processing costs of an on-line electronic transaction.¶¶

(h) Physical Therapist or Physical Therapist Assistant Temporary Permits Fee of \$50.00.¶¶

(i) Duplicate License Fee of \$25.00.¶¶

(j) Physical Therapist or Physical Therapist Assistant NPTE Early Eligibility Release Form processing fee of \$25.00.¶¶

(k) Physical Therapist or Physical Therapist Assistant Verification of Oregon Licensure or Verification of Application Status Letters/Forms Fee of \$25.00.¶¶

(l) Non-Sufficient Funds (NSF) Check Fee of \$25.00.¶¶

(m) Miscellaneous Fees:¶¶

(A) Physical Therapist and/or Physical Therapist Assistant electronic mailing list fee of \$100.00.¶¶

(B) Photocopying administrative fee of \$25.00, plus ten cents (\$0.10) per copy.¶¶

(2) Board refunds of overpayments in any amount of \$25.00 or less will be held by the Board unless the payor requests a refund in writing.
