OREGON AIRCRAFT DEALER'S LICENSE APPLICATION

ORS 837.075 - AIRCRAFT DEALER'S LICENSE

- (1) Any dealer in new or used aircraft, or both, shall apply to the Department of Aviation for a Dealer's. License. Upon such application, the department shall issue an aircraft Dealer's License to the applicant for an annual fee of \$250.00. The Dealer's License shall be in lieu of all other licenses or registration required by ORS 837.040 upon the dealer's aircraft within this state, so long as they are kept for resale and are not used in commercial operations within this state.
- (2) This section does not prohibit the registering of a dealer's aircraft under ORS 837.040.
- (3) Upon sale by a dealer of an aircraft which is not registered under ORS 837.040 the dealer shall advise the purchaser of the registration requirements under ORS 837.040 to 837.070.
