13 Act (Chapter 183), Oregon Revised Statutes, and fully and finally waive the right to a contested  
14 case hearing and any appeal therefrom by the signing and entry of this order in the Board's record.  
15 You agree to conduct all future business in compliance with the applicable statutes, administrative  
16 rules, and specialty codes. You understand that, once final, this Consent Order is a public record.

17 **FINDINGS OF FACT and CONCLUSIONS OF LAW**


- 18 1. On or about August 17, 2012, at 907 Reserve Street, Silverton, Oregon, you installed a light  
19 and electrical switch in a shed, without a supervising or journeyman electrician's license.  
20 2. On or about July 1, 2013, at 834 Madison Street, Silverton, Oregon, Respondent installed an  
21 electrical service panel, without a supervising or journeyman electrician's license.  
22 3. Installing a light and electrical switch in a shed and installing an electrical service panel are  
23 electrical installations as defined in ORS 479.530(10).


- 1 6. You understand and agree that any violations of the Building Code Division's statutes or  
2 rules not alleged in this Consent Order, whether committed before or after the execution of  
3 this order, may be the basis for further enforcement action.
- 4 7. You understand the suspended civil penalty will be waived five years after the execution of  
5 this Consent Order, provided you comply with the order's terms and have not committed  
6 any further violations of Building Codes Division's statutes or rules.
- 7 8. You have read and fully understand the terms of this Consent Order, freely and voluntarily  
8 ~~consent to the entry of this order without further hearing, without any force or duress, and~~  
9 expressly waive all rights to a hearing or appeal in this matter.
- 10 9. You understand that, upon signature of all parties, this Consent Order will be a  
11 FINAL ORDER.
- 12 10. You further agree by signing this Consent Order that you are the Respondent or authorized  
13 representative for the Respondent in this matter.
