If the guardian signs, a copy of the court papers showing guardianship must be submitted with the affidavit.

Submit this affidavit along with the ownership document, if any, a Notice of Sale/Change of Ownership form, (440-2952), the death certificate, any duplicate Inheritance Transfers, and any other supporting documentation to the county office of the county in which the home is located.
