Deferred submittals are appropriate when a portion of the plan for a structure is submitted for review at a later date than the original submission; examples are listed below. Applicants who wish to defer items should contact the appropriate Building Codes Division (BCD) field office or BCD's Salem office.

PROCEDURE

- 1. List deferred submittal items on the title or cover sheet of the original plan when the application is made or complete deferred submittal application.
- 2. Schedule (as needed) a pre-submittal conference to discuss proposed submittal items.
- 3. During the pre-submittal conference, define the deferred submittal schedule.
- 4. Ensure that the deferred submittal documents are reviewed and approved by the architect/engineer of record to verify that items comply with the general design of the building, before submitting to BCD for plan approval.
- 5. Deferred submittal documents and drawings shall be submitted for review and approval by BCD prior to the construction/installation of the deferred item.
- 6. Fees will be charged for deferred items (see the table below and OAR 918-460-0070).
