The State Board of Licensed Social Workers will hold a two-day planning meeting beginning at 9:00 a.m. on October 26 and 27, 2012, after conclusion of the Board's Rulemaking Hearing at the Board Offices on the same day at 8 a.m., previously published on the Board's web site and through the Oregon Secretary of State. A detail agenda for the planning meeting including meeting times and topics for specific committees is attached (Attachment 1). A separate agenda for the Consumer Protection Committee (CPC) of the Board is attached separately hereto as Attachment 2. The CPC agenda includes Executive session under authority of ORS 192.660(2)(f)(h)(k) to discuss pending complaints, consult with legal counsel, or conduct interviews. Final actions regarding any matters taken to the Board from the committee and planning meetings will take place in the regular Public Meeting of the full Board on Friday, October 26, 2012, or on Friday November 16, 2012.

The full Board will hold a Board meeting starting at 11:30 a.m. on October 26, 2012, to include Executive Session under authority of ORS 192.660(2)(b)(f)(h)(i)(k). The estimated start time for Executive Session that day is 11:45 a.m. and is expected to last at least 1 hour. Public Session of the Board will commence immediately upon conclusion of the Executive Session. A detail agenda for the full Board meeting is attached as Attachment 3.

Members of the public will be able to observe the public portion of these meetings at the Board's Salem office. The meeting location is accessible to people with disabilities. A request for an interpreter for the hearing impaired or for other accommodations for a person with disabilities should be made at least 48 hours before the meeting to the Executive Director at the above address and telephone number.
