

RULE SUMMARY

Implements certain Senate Bill 177 (2009) provisions that become law on January 1, 2010, including renaming the Board to "Board of Licensed Social Workers," and defining "practice of social work" in ORS 675.540 as "practice of clinical social work." Streamlines licensing renewal by limiting the requirement to submit continuing education reports and eliminating the requirement for LCSWs to attest to active practice of clinical social work. Specifies Board recognition of accrediting bodies and foreign degree equivalency determination. Specifies application process and requirements for former license holders. Conforms Board mandatory reporting requirements to House Bill 2059 (2009).
