Models that are a Best Value are not necessarily the lowest priced Models.

CONSIDERATIONS OF PRICE AGREEMENTS:

State Agencies: Purchases over \$150,000 must be administered in the same manner as your agency's process. Purchase orders must be reviewed by DOJ, and a Contract Verification Form (House Bill 2375) must be completed and all associated documents kept with the purchase documents.

NOTE: According to HB 2017, on January 1, 2018 vehicle dealers in Oregon are
responsible for paying a "Vehicle Privilege Tax" of 0.5% on any new taxable vehicles
sold in Oregon. This tax will show up as a separate line item on vehicles quoted
against your purchase order(s). For questions concerning this tax, please refer to the
Oregon Department of Revenue.
