    - Julie S Should we go through Patrick Flanigan (LCIS), and have them communicate to the tribes?
      - Alyssa Yes can work with Patrick
      - Valeria Please send to TAC as well
- Overview of Equity and Civil Rights Specialist
  - Can we take anything from this JD and use them for the Alliance Manager?

Alyssa Chatterjee, Early Learning Systems Director, ELD

  - Valerie the organization waned during covid, trying to revamp the org now
  - Overall feeling not sure who is involved
  - Valerie Paul Lumee from NAYA would be a good resource
- Early Learning Council is preparing the next strategic plan
  - Want to make sure the TAC is involved, we didn't have strong consultations last time
    - Alyssa does the TAC want DELC to bring information from the strategic planning meetings?
    - Angie suggests making time on the TAC agenda
    - Alyssa we can work on a timeline and send it out rather than use TAC agenda
- Update on background checks delays
  - Alyssa We just got 35 people trained up and clearance on the IT front.
    So, we have more people helping. If anyone has questions let us know
  - Valerie yes, we have heard from Deannie that the delays are impacting the grant budgets
  - Alyssa we can't revert to emergency background checks, but we are looking at efficiencies / platform changes to speed up process

  - Follow up on totals and follow up on questions asked. IGA being drafted should be released by next week. Noticed of funding awards drafted in parallel so the tribes can take to leadership.
