iii. October Meeting Recap – 5 Mins

Sandy Henry, Vice-Chair, Cow Creek Tribe Rep

- RE: Capital Investment use of Funds; Alyssa offered her time to work with the tribes to find creative funding options for capital investments, since the GF and PDG funds cannot be used for capital investments

October Recap

- Reviewed Positions Descriptions for
 - o Tribal Affairs Director;
 - o Tribal Affairs Manager (OTELA Manager)
 - o Tribal Affairs Program Coordinator; and
 - o Equity and Civil Rights Specialist
- Position descriptions + Alyssa's edits sent out to TAC for feedback
- TAC decided to use current biennium funds for website development (\$50k), that will leave \$133,444 for each Tribe.
- · TAC had few questions around use of funds:
 - o Early Learning & Child Care Resources
 - Wage increases for early learning staff (GF)
 - Expansion of program services cultural Mondays, child/family activity boxes, etc. (GF or PDG GF recommended)
 - Funds cannot be used for capital investments such as purchasing a van or bus for transportation or capital
 improvements.

iv. **TAC Breakout Session & Recap** – 20 mins

Valerie Switzler Chair, Warm Springs Tribes Rep

Notes / Actions:

- TAC has feedback on job descriptions
 - Valerie looked at the duty % breakdown. Can we strike out consultation on the Government to Government for the role? Rational is because that should fall under the systems director (Alyssa)
 - Modesta Our consultation processes are different among the 9 tribes, we didn't think bringing that responsibility down to the management level made sense.
 - Alyssa yes, we can take that feedback and edit the Job Descriptions.
 We can send out after edit to collect further feedback.
- Valeria Question for TAC Since we are removing that consultation responsibility, should we increase the % in other duty areas?
 - Valerie we should just change the word "consultation"

- Sonya yes it would be a different person we would consult with, would be above the position, they can help but wouldn't be responsible
- Julie shared a concern there has been examples of state employees talking with tribal employees and calling it consultation to the public when it wasn't.
- Valeria thank you for sharing and helping us get the language right.
- v. Raise Up Oregon 2.0 / Early Learning Council Strategic Planning 25 Mins Angie Blackwell, Grand Ronde Tribe Rep and ELC Member Sue Miller, Chair, Early Learning Council Remy Watts, ELC Administrator, ELD

Notes / Actions:

- Alyssa ELC wants to ensure we get tribal consultation on the front end of the
 next iteration of the strategic plan, how do you want tribal early learning goals
 reflected in the plan and how do you want to be engaged in this work? Need to
 make sure we are being intentional and get strong consultation. The strategic
 plan will be the road map for our work together.
- Sue Miller Very excited to have the TAC and excited to hear about OTELA. Will be an adventure to see the development and roll out of the organization. The council is very supportive of it and are looking forward to learning and partnering. We were neglectful 5 years ago about consultation, so we want to change that in this round of planning. We have a lot to learn from the Tribes. This whole process will be excellent and helping us build relationships. The council is excited and knows it will be on the learning curve. Angie has been a great representative on the council and has done a great job.
- Angie Thank you Sue, I believe the consultation happened in G2G rather than
 the current agency, because it didn't exist. I feel confident the council and agency
 are committed to this relationship. Next step is really formalizing this through our
 strategic plan and raise up Oregon. I appreciate the intention and feel confident
 we can make it what we want it to be.
- Remy Watts We are in the process of developing an introduction to an early draft of RUO 2.0. I am here to talk about where we are and where we are going, and I will share a Jam board with some questions to collect feedback from you all.
 - o Remy then presents slides to the TAC. Slides can be sent out.
- Valerie I have a thought where do the slides talk about building on the strengths that are there in the community? How do we bring that out more?
 - Remy Not sure?? Alyssa? Sue?
 - Alyssa Good feedback, that's the type of information we want to reflect through this process. How do we capture what is working well and lift Those up as models to scale, rather than pursue a path that duplicates efforts or starts over. Tribes can be good examples of what is working

- well, will be wonderful to lift that up and talk about building that up rather than starting over.
- Sue Its an excellent question one of the things we are learning is that there are many strong models and programs that are having a positive impact, and we are doing our best to share those models and programs we can all learn from one another. I appreciate your question.
- o Remy one of the Jam board questions will be related to this e.g. what is working well, how can we build on and replicate
- Sue 2 weeks ago the governor appointed Ben Cannon to the council, so there are now 6 state agencies' partnering to build the early learning program.
- Jennifer Jackson comment about RUO, the objectives focused a lot on preschool aged children and not a lot for 0-3 aged kids. Will there be more funding available for this age group?
- Remy We can prioritize 0-3 population in the planning, then we can start moving the funding over to that population
- Alyssa As we create this plan, we want to emphasize infant / toddler strategies, so we have bold expectations and make the case to the legislature to fund the work.
- Sue we only have 1 committee to date, creating a committee help emphasize this work
- Remy shared timeline, but it is pie in the sky, and not an absolute and much of the information gathering / collaboration is just now starting.
 Phase of community engagement is just starting
- Alyssa the TAC is coming in at the beginning of the engagement process, the December meeting coming up is a reflection document rather than a draft plan. We are in the early stages of "what's been happening"
- Alyssa I expect the timeline to shift

TAC Homework:

- Commit to reviewing Raise up Oregon and think about Keep, Start, Stop. What needs to be modified? What specific strategies or objectives would like to see for tribal children? What expectations and standards for the agencies?
 - Jam board created to collect feedback
- How does the TAC want to engage in this work over the next 7-8 months or beyond?

vi. Barriers Discussion – 20 Mins

Sandy Henry, Vice-Chair, Cow Creek Tribe Rep

Notes / Actions:

- Short on time for this topic, only 9 minutes remaining
- Sandy One of the things we felt was important was how do we help our tribal providers navigate through the system of licensing and conducting business. One of the areas we called it "Grievance." I would like to refrain that to "barriers" because grievance is very loaded. We need to be careful about laws, but we can help with barriers that get in the way of licensing e.g. bathrooms, square footage requirements. Infrastructure and licensing, staff (ORO numbers).
 - TAC will need to come up with a process and guidelines about how we will be able to help the tribal providers navigate the system.
 - Homework think about it and come prepared in December's meeting to discuss what that will look like. If there are questions or concerns about a barrier that falls under an ORA or ORS then Alyssa or Valeria can help.
 - o Valerie does that nutshell the discussion?
- Valerie yes, but we also want to bring up the native language teacher / culture education and how that license will be beneficial to recognize in early learning.
- Sandy Example I was shocked and embarrassed as child welfare
 professional with a bachelor degree, I turned in all my information and I was an
 ORO 3. I think as I group that is a place we can step in and help. This is the kind
 of stuff we need to look at.
