#### v. **OTELA Manager Position Description** – 25 Mins

- Valeria screen shared OTELA position description and walked the TAC through the document.
  - Document will be sent out to the TAC to digest further
  - Section 2 Job Description Summary:
    - Sandy I like the line about eliminating barriers that prevent tribal nations from enacting their sovereignty
    - Valeria A lot of the responsibilities of the manager role relate to Valeria's new role as Director. With feedback we received from TAC we retitled the first area as management of Oregon Tribal Early learning Alliance.
  - Valeria The TAC will transition into the OTELA governance board and will consist of tribal members as well?
    - Angie / Sonya can you repeat the question?
    - Valeria Yes, the TAC has talked a little about what the transition will look like. OTELA will be a governance board and appointed in a similar way as the TAC
    - Sandy yes, the TAC will transition into the OTELA governance board.
    - Valeria is that new information for anyone? Sorry if we weren't recapping that well in meeting minutes.
    - Sandy I think we got confused because the governance board isn't opened for anybody
    - Sonya I think that came up because we have tribal members who do good work for the tribe but do not speak for the tribe.
    - Valeria great I will make sure it is updated in the notes
  - Highlighted portion of PD is a note for the TAC to note the responsibilities are an exact match of Valeria's previous position. We will be deleting the highlighted portion once the position is finalized
    - Sandy We are regarding this position as more of the boots on the ground, work with the tribes?
    - Valeria yes, and you can see it's not in place of our director as well, as you can see in the language change in the governmentgovernment language.
  - Jonas The position description mentions the OTELA manager will define and implement the barriers process? Does that mean we can close that topic?
    - Valeria No, it will be the continuation of the work
    - Sandy I foresee the manager doing the research to find out what ORS/OAS hang-up we are going to have. We are trying to eliminate a barrier. Once a barrier comes up the manager will find out legal constraints there are around that. But I'm speaking for

me, not the whole group. If anyone else has anything they can speak now?

- Sandy How are we feeling about the PD so far guys?
  - o Valeria Anything you like or don't like?
  - Sandy Not hearing anything.
- Valeria we updated the government-to-government language to include "have knowledge of"
- Valeria do we still have quorum?

- Sonya I know you said we are not specifically called out. Were our tribal programs asked to give feedback on the plan?


- Angie No. only if the programs are a part of the grantees. However, you

## **Approach to OTELA Identity Guide**


Approach to OTELA logo design, color theme and fonts
