iii. Raise-Up Oregon Engagement – 20 Mins

Remy Watts, ELC Administrator / Sue Miller

- @Sue Miller joined the call to speak about ROU 2.0 Oregon + TAC Engagement.
 - This meeting a prelude to future conversations over the next several months
 - Invitation for the TAC members to join the March 22nd ELC Meeting, where there will be time on the agenda to hear feedback from the TAC on the plan.
 - Strategies shared are drafts / examples. The TAC may come up with additional strategies.
 - Slides covered: (slides shared with TAC members)
 - Draft goals for RUO 2.0
 - Draft plan structure
 - Objective 4, goal 1
 - Honor and recognize the sovereignty of the nine federally recognized tribes within Oregon's borders and ensure strong G2G relationships to benefit Tribal Communities
 - Objective 8, goal 2
 - Families have expanded access to culturally and linguistically responsive and specific family preservation strategies, resources and programs focused on the prenatal-to-five population.
 - Examples of objectives supporting cultural responsiveness

- Next discussion will be held March 22nd. Please look at the goals, objectives and strategies and let us know what looks good, what is missing? Would love to get your feedback.
- Link on the ELD where anybody can provide feedback on the draft RUO 2.0 Plan.
- What we know, is that after having the plan exist for 4 years and our having 6 agency partners/sectors represented. The plan serves as a north star for agencies that are working with families with young children. The plan is used at legislative hearings, the Governor's office is aware of it and using it and likes that the agencies are reaching out to the tribes.
- o Anything to add Alyssa and/or Angie?
 - @AlyssaC Angie, I look to you
 - @AngieB Not much to add but want to reiterate it's not just a rewrite of the existing plan, but also additions and actions we think are appropriate for the different objectives. The plan applies to all Oregonians, with some specific pieces that apply to tribes, and others that apply to equity. There are a lot of different pieces, and I am Hoping we could provide some feedback to the council on the 3/22 meeting.
 - @AlyssaC I just want to acknowledge this was a glaring oversite in the current version of RUO (tribal consultation), we want to be intentional (about consultation) especially because we are becoming a new agency. We want to center that G2G relationship. We look to you all about how you do want to show up in the plan, whether that revising adding objectives / strategies. We want to ensure tribal nations have a voice in the states early learning system.

iv. **TAC Breakout Session & Recap** – 20 mins

Sandy Henry, Vice-Chair, Cow Creek Tribe Rep; Valerie Switzler, Committee Chair, Warm Springs Tribe Representative

- @Val We would like to have a get together of the 9 tribes (OTELA). To work on the feedback for RUO 2.0. One of things that was noted in the breakout session, people expressed is that the state has been working on this a long time, but we are just now being asked to provide feedback in the next couple of months, this does not follow tribal consultation. We are willing to look at things to try to work out as much of the materials as we can. Sandy, did I do alright?
 - @Sandy Yes, we would like to look at some actions under the objectives and strategies and help formulate those. Val is going to send

- out a doodle pool so we can all get together, can you make sure we all have access to the draft plan, can you send it to us via email?
- o **@Valeria** Yes, we can do that
- @Val instead of me sending the doodle pool can you send it out Valeria?
- o **@Valeria** Absolutely
- @AlyssaC Are there any key questions or anything we can do to help? We'd brought this to the TAC last year and I knew we hadn't got a lot of feedback in the surveys. Is there anything else we should be doing? given the stretch capacity you have to make the best use of your time? Since we've not been able to get it right, and the hopefully center G2G consultation when we first started the conversation.
- @Val that wasn't brought up in our breakout session, but we've been working so hard we never did comeback to revisit the RUO planning.
- @JulieS Val okay to ask a question? Is 3/22 a hard and fast deadline or can it be pushed back?
- @AlyssaC Yes, I was surprised to see the March date. The council meets monthly so we can work with the chair, but I imagine we can join any meeting between now and June. Council hoping to adopt the plan in June. We first came to the TAC in oct, then sent the survey in Nov, the hope is to continue engagement thru the next few months, then continue to refine during the summer, then in the fall it could roll out. There will be opportunity in the next phase to co-create to meet the needs of the family, providers, and communities we are serving.
- @JulieS From now until June is working time? Summer is re-work, still working through things?
- @AlyssaC yes, summer will be fine tuning, but we wouldn't see major changes. Would be clarifications and how to operationalize and communicate.
- @JulieS It sounds like this will be a working document? So we can revise if we have different concerns? You'll work with us on that?
- @AlyssaC yes, one of the exciting pieces about raise-up Oregon is that it's not just the ELD this is an opportunity to define what you want to see from healthcare or human services, so it really can be, what are the needs of the community and the families or providers you are working with.
- O @JulieS So the needs drive the design?
- o **@AlyssaC** Yes, absolutely, the skies the limit
- @Val thank you for offering to help. It will be wonderful to get the 9 tribes together. There's a lot of synergy, we can certainly put a number of things down.

v. Infant Early Childhood Mental Health – 20 Mins
Katrina Miller, Infant and Early Childhood Mental Health Specialist

- @KatrinaM infant and early childhood mental health specialist, hired to help build out the program
- Located in Portland, background in Infant and Childhood mental health consultant.
- **@JuliaL** Grants coordinator, helping Katrina with the fiscal side of things.
- Katrina gave presentation on the Infant Early Childhood Mental Health Program (slides are available / shared with TAC).
- Decision for TAC: Option 1 or Option 2



- @Valeria This is something that I have heard on other calls. That there's this
 interest creating support in preventing the pushout of native children in early
 childhood spaces, there's no process yet for native children who is being pushed
 out of program. Nothing to prevent that. Many programs currently have mental
 health support in other ways. We want to make sure we include the tribes in this.
 Some of you have been involved in this, back in the 20-21 legislative session.
- @KatrinaM We want to start the conversation
- @Valeria just want to add, like RUO this is an item that falls under consultation as well. There is multiple opportunities coming up to see other options, this is all very much draft and open to your input where comes to needs. I know a few tribes have programs / consultants at your nations, what could be your needs for that? This is an invitation to start that conversation, that will follow with an invitation to the advisory committee that's being formed. We are very early in our process for request for applications or what that would look like. So we can learn more about specific needs and tribes needs.
- @AngieB Can I say something? Our program has a mental health practitioner within the program, and I use multiple funding sources to fund that person. I worry that smaller programs may not have other resources, and small grant may

- not be enough. I like the idea of the dedicated person, I like both ideas, I just worry if the dollar amount is too small it might now be meaningful.
- @Val- Here in Warm Springs, in rural areas it is difficult to find these professional to come out to the reservation. What would that grant look like to competitive or entice someone to come out to the reservation? If we have those folks employed in Salem then visit other parts of the states, it's a lot of travel. Would it be a person on one side of the mountain then another person on the other side of the mountain? Those are the wondering I have.
- @SonyaM I have the same concerns. How would it be possible for 1 full time unless it was connected tribes to available resources in their communities. The other thing that goes along with the grant dollars being smaller, it's the availability of finding someone. They're limited mental health people available.
- @ModestaM Looking at both options, I think there's a combination that might work for the tribes. What we must remember the goal of each of our tribes is to be sovereign/independent, getting grant money allows us to make out own decisions. Put money it what we believe works. We learn as we grow and branch out and expand. Finding professionals could prove difficult, but if there was a person at the state who is dedicated to the tribes could be helpful as well.
- @KatrinaM Yes, the drive is long. A wondering that I've had, if this position
 was at the central entity whether the person is physically located could we find
 someone to fill the role who could also supervise other consultants and expand
 the cultural responsiveness, of a broader group of consultants.
- @julieS the person is fluid at the moment? The person could be someone like LCIS, a person representing all 9 tribes. That helps coordinated the needs for each tribe. Am I following your thought line?
- @KatrinaM I think you are being a little more specific than I have been. The
 question would be whether be is this the individual who providing the services
 themselves and is connected to all 9 tribes? OR helping to facilitate the services.
- @julieS I don't think 1 person could do all that. Each tribes has a wide variety of needs. Maybe? I don't know?
- @Valeria I think it is worth mentioning, I like the idea of central navigator that
 could make those connections with folks who are already providing mental health
 support. We know there's a big movement around community health works and
 people who help with healing. It could be those folks, it doesn't have to fall in a
 prescriptive category.
- **@Val** what I hear is this could also be a non-traditional type, could be spiritual leaders? Could be Indian doctors?
- @Valeria yes, absolutely. We will follow up with slides from both presentation and notes so you can keep thinking about this. We will also send meeting details in case you would like to join those conversations.
