 - Need to clearly define what we will do with grievances
 - o Staff
 - Need to draft a JD and figure out cost for Alliance manager
 - Angle let's not rule out using another person to fill this role, don't want any confusion about who this person works for.
 - Alyssa we may have something in place that can help solve the confusions. If not, we can at least get the cost
 - Alyssa compiling relevant JDs and getting cost estimate (based on tribal affairs manager role)
 - Website

- Need to ensure whatever is posted on the DELC site is also posted on the tribal hub page. Need to be able to see funding notices and rules. Pertinent information from DELC.
- Cayuse to get cost estimate
- Reportable Metrics
 - Need some sort of metrics to put in front of the legislature to show proof of impact
 - Measurables should tie back to the purpose
 - Documented several new metrics based on purpose
 - Track providers accessing public funds
 - Tracking funding
 - Tracking Grievances (type and resolution)
 - Tracking professional development for TAC members
 - Family engagement
 - Angle Decisions making process? May not be a council but could community input or survey? Thinking about how track that input
 - Activities nights?
 - Angie make sure to track waitlists under enrollment

 - Oregon Tribal Early Learning Alliance




IV. Role Definition / Governance - 5 Mins
