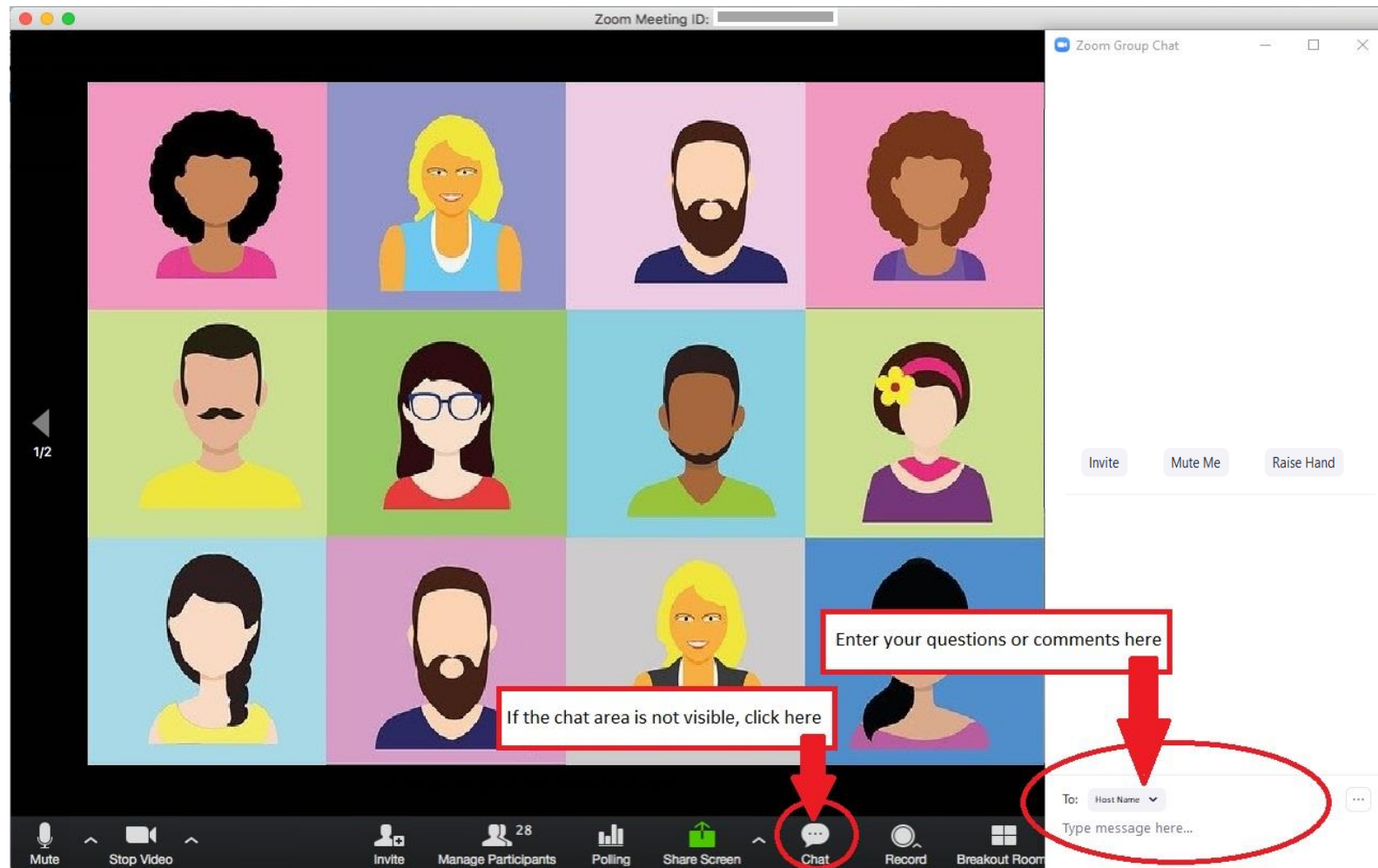

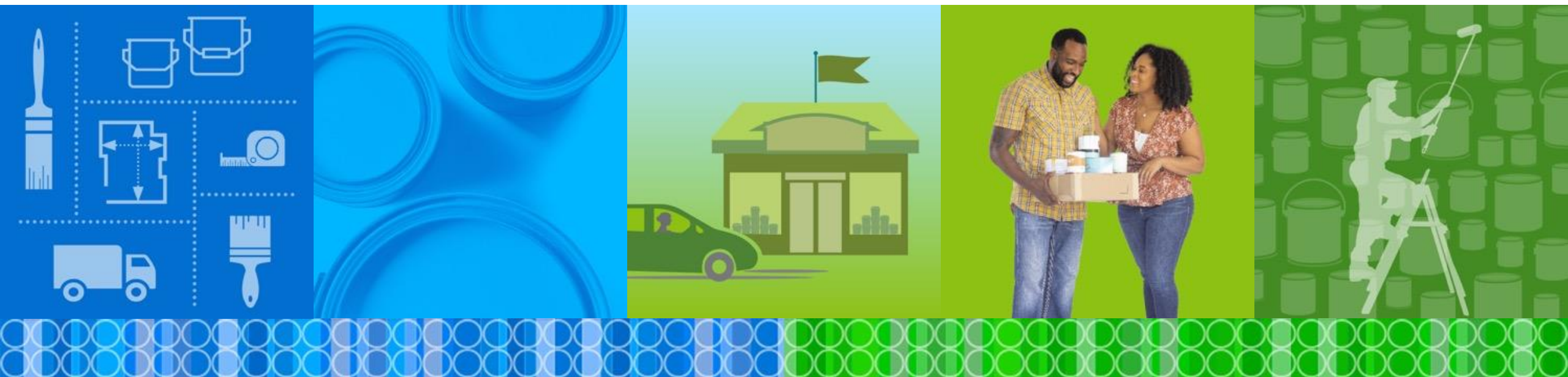

Paint Drop-Off Sites and Services

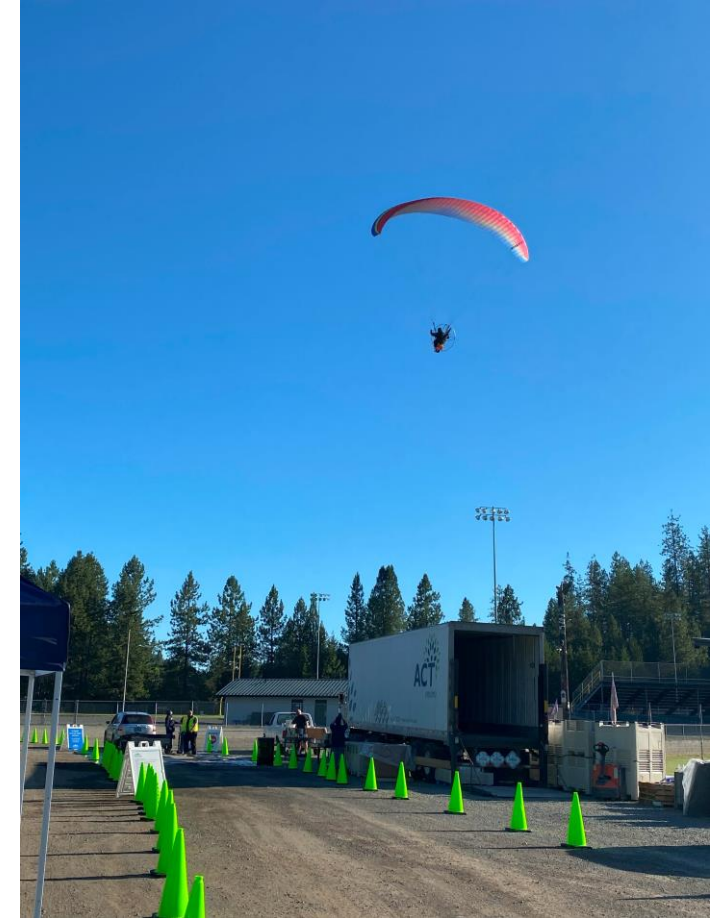
- 182 year-round sites
 - 133 paint retailers
- 98.3% of Oregonians live within 15 miles of a drop-off site (supplemental sites included)

PaintCare Drop-Off Events

- PaintCare hosted 5 collection events in 2022.
- Events included free giveaway of some paint in good condition.

Paint Collected

- A total of 697,872 gallons of paint were collected during the year
- Latex paint recycling rate was 74%

Program Awareness and Source Reduction Studies

- Amendments were conditionally approved, pending adjustments to survey distribution
 - Updated amendment to be submitted by November 1, 2023



Looking Ahead

- PaintCare began a three-to-five year effort to visit non-drop-off sites.
- PaintCare's first paint giveaway event will take place on August 26, 2023.
 - The event will be held at the Centro Cultural in Cornelius, OR.

2023 Annual Paint Stewardship Meeting

History and Year-to-Date

- 2009 – legislature passes paint stewardship law
- 2010 – pilot program begins
- 2013 – program becomes permanent
- Since 2010:
 - 13 years of paint stewardship in Oregon
 - 8.8 million gallons collected

2023 Annual Paint Stewardship Meeting

Definition

A wasteshed is defined in Oregon law as being an area of the state that shares a common solid waste disposal system.

For most of Oregon, a wasteshed is an individual county except the Milton-Freewater and Metro wastesheds.

Highlights

- Roughly half of the amount collected (55%) came from the Metro wasteshed
- Deschutes (8%)
- Lane (8%)
- Marion (7%)
- Gilliam (0%)
