1	Consideration of Legislative Concept: (Vicki S. McConnell, State Geologist)
2	Action Item
3	a. DOGAMI seeks the Board's approval to update statutes governing
4	Coal and Metal Mining, ORS 517.905 to 517.951. DOGAMI staff and
5	DOJ staff will brief the Board on the issues the proposed legislation
6	would revise.
7	McConnell gave the background on the need for a revision of the Coal and Metal
8	Mining statutes. Lynch and Knudsen briefed the Board on the details of the proposed
9	Legislative Concept. DOGAMI through the Mineral Land Regulation and Reclamation
10	Program (MLRR) is the primary regulatory agency for the state in regard to coal and
11	metal mining operations to ensure beneficial secondary reclamation. The statutes for
12	this regulatory activity have not been reviewed or revised since enactment in 1981.
13	The statutes are in need of revisions because the financial security provisions are
14	inadequate. The timelines for permit processing are unrealistic, in view of increased
15	regulatory complexity. The statutes do not authorize the Governing Board to establish
16	requirements for public notice and comment and may restrict DOGAMI's authority to
17	partner with other interested agencies. Some of the statutory provisions are also
18	inconsistent with or duplicate provisions that exist in the general and chemical process
19	mining suites of statutes.

20 21	b. Public Comment regarding the proposed Legislative Concept: (three minutes limit per person unless otherwise specified at the meeting by		
22	the Chair)		
23	Larry Tuttle believes there are some gaps in the metal mining statutes and offers		
24	his assistance with revisions. He believes there will be increasing metal mining		
25	applications. He reminded the Board of the Formosa mine and said that had there been		
26	metal mining statutes that more closely mirrored the Chemical Mining statutes that		
27	much of the problem could have been eliminated before it became a problem.

29	Motion: Vars moved to approve the agency's request to pursue to proposed		
30	legislative concept. Phipps seconded. Voice vote: Vars- yes, MacDougal – yes,		
31	Phipps – yes, Givens – yes. Motion carried.
