1) Call to Order:

a. Update on Board recruitment: *Update Item*

Charles Vars has agreed to a second four-year term, subject to confirmation by the state senate. Chair Haagensen's term expires 12/31/2009 and the Board still needs to get some recommendations together. Haagensen submitted the resume of one of his colleagues as a possible candidate.

b. Election of Board Chair and Vice Chair: Action Item

Vars nominated Macnab for Chair. Macnab nominated Givens for Chair. Macnab would prefer to serve as Vice Chair, rather than Chair. Vars withdrew his nomination for Macnab, and seconded the Givens nomination. Motion passed.

Vars nominated Macnab for Vice Chair, Givens seconded. Motion passed.

5) Board Adjourns to Cannon Beach City Hall to attend Tsunami Vertical Evacuation Public Forum

7) State of the Agency: (Vicki S. McConnell, State Geologist)

a. Discussion of Executive Order 09-13 – Resetting Government: *Information Item*

The Governor believes the main tenets of government are education, public service and health. He would like his task force to prioritize core functions including consolidation and elimination of Boards and Commissions, and improving outcomes, controlling costs and maximizing efficiencies by consolidating service delivery and providing greater flexibility where needed.

There were various recommendations outlined in a subsequent letter on this topic that could possibly impact the agency. However, during follow-up, McConnell discovered that these were merely conceptual and at this point these ideas will not be pursued. Mike Carrier, the head of the Governor's Natural Resource Office will be testifying on October 1st before the House Committee on Environment and Water, to discuss consolidation of the natural resource agencies.

Haagensen noted that this has been discussed numerous times in the past and the legislature has consistently decided that it would make no sense to consolidate natural resource agencies. He said that the agency's general fund has been consistently cut back, but has survived because of innovation and hard work to acquire funding from other sources, and he doesn't believe that a bigger agency would be able to accomplish this.

McConnell recommends that the Chair call Mike Carrier prior to his testimony to ask him what the testimony will be about and to offer assistance with background information.

b. Agency activities update: Update Item

McConnell briefed the Board on current projects, proposals, and activities outlined in her memo. She noted the new Oregon Geologic History map slated for release in a week or so. We will be giving a copy to each middle and high school in the state and will present a framed copy to the Governor. The Geologic Society of America conference will be in town in October and DOGAMI has been very involved in the planning for the past year. She also briefed the Board on upcoming statewide furlough days.

c. End of Biennium Financial Report: Update Item

Don Lewis gave a brief presentation on the financial status of the agency and said we are in good financial shape in spite of the grim economic outlook. However, with the downturn in regulatory fees and the need to replace general funds with other funds, there is still a possibility of financial risk if the legislature cuts our budget again.

8) Regulatory Issues: (Gary Lynch, Mineral Lands Regulation and Reclamation Program)

a. Status of rulemaking for aggregate, oil and gas, geothermal laws: *Update Item*

The draft Oil & Gas rules will be ready for the rules advisory committee in mid-October. Geothermal rules will be started in January. The rule writing on the aggregate statutes for SB 149 has been completed. Haagensen believes the geothermal rules should be prioritized and written as quickly as possible.

The Board requested that Larry Knudsen identify any possible problems that may occur if we don't have rules in effect quickly so the Board can make an informed decision on whether or not to prioritize geothermal rules over oil and gas rules.

b. Status of US Geothermal's request for unitization at Neal Hot Springs: *Action Item*

McConnell attended a meeting with the BLM and US Geothermal in Boise ID. She briefly defined unitization for the Board and US Geothermal's withdrawal from requesting unitization at Neal Hot Springs. She recommends that we adopt the BLM unitization process to fit our needs.

c. Summary of operational and enforcement activities for surface mining and oil and gas and geothermal regulatory programs: *Update Item*

The Columbia County transition has gone quite well. There are no high priority enforcement actions at this time.

- 9) <u>Coastal Field Office Programs and Priorities:</u> (Don Lewis, Geologic Survey & Services Program and Jonathan Allan, DOGAMI Coastal Geomorphologist) Board considered these agenda items as training.
 - a. Oregon Tsunami Hazard Mitigation Program acceleration is now possible with additional NOAA funding: *Update Item*

Lewis summarized the program and gave a brief presentation outlining our progress towards accelerating the mapping of the entire coast of the state and developing outreach to educate the populace.

b. DOGAMI involvement in the LCDC Climate Change Policy and request for Land Use Goal 20 – Sea Level Rise: *Information Item*

Jonathan Allan gave a presentation to the Board that focused on recent discussions of climate change impact, in particular the impact of sea level rise on coastal infrastructure.

10) Set Date and Time for next meeting: (Board)

The next meeting will be on Friday, January 15, 2010 in Portland.
