Welcome and Introductions/Meeting Protocols

• Steve Faust introduced himself and the DSL staff members before briefly going over meeting protocols.

Meeting #5 Follow-Up

- Reviewed the proposed changes that came out of last month's meeting covering Waterway
 Habitat Improvement GA. These proposed changes are listed in the "RAC Meeting 5 Comments
 Log".
 - 141-089-0790 (1)(b). <u>Prior RAC Comment</u>: Unclear if term "capture mainstem flow" is intended to mean any flow. <u>DSL Proposal</u>: Proposed Language modified as follows: "...and the reconnection cannot result in *de-watering* mainstem flow; and,"
 - Most support this change. Melinda recommended clarifying if this is dewatering in totality or if can't change waterway type such was perennial to intermittent or ephemeral.

- 141-089-0790 (8)(a). <u>Prior RAC Comment</u>: Change the sizing requirement to a performance-based measure similar to large wood sizing change in the Streambank Stabilization GA. <u>DSL Proposal</u>: Language modified as follows: "At a minimum, wood pieces, or their cumulative effect, must be of a size sufficient to withstand bankfull rates of flow."
 - Chris suggests a 25-year event. No objections to this proposed change.
- Reviewed the proposed changes that came out of last month's meeting covering Wetland Ecosystem Improvement GA. These proposed changes are listed in the "RAC Meeting 5 Comments Log".
 - 141-089-0805. <u>Prior RAC Comment</u>: Add an eligibility requirement for ODFW habitat incentive agreements. <u>DSL Proposa</u>: Added as a new (8): "Consistent with Habitat Incentive Agreements. If the project is under a Habitat Incentive Agreement with ODFW, the activities must be in conformance with that agreement."
 - Chris Gannon. Does this requirement need to be in the GA? Why is this important? Nancy at ODFW replied "These agreements are LONG term and there is not consistent oversight thru time... ensure that the activity conducted by the GA does not undo the benefits previously achieved." This purpose is more of a reminder to comply with agreements already made. It's not mean as another form over oversight.
 - Nancy at ODFW would like this added to the Waterway Habitat Improvement GA.

- DSL is required by law to submit supporting documents and would like RACs input. 1) Need for the Rules 2) Fiscal and Economic Impact 3) Cost of Compliance 4) Racial Equity Statement.

 - 1. Chris Gannon. Need to add "er" after "long".
- Fiscal and Economic Impact. "Div 89 Draft Fiscal Impact Statement 10262023.

- 3. DSL will file for 30 day public comment period. This is expected to occur in January or February 2024. DSL will hold a public rule hearing either 1/16/2024 or 2/15/2024. Can't be held before the 15th of each month due to public hearing laws. The hearing will have a presentation followed by Q&A session.
- 4. DSL will review public comments received.
- 5. DSL will edit rules as appropriate.
- 6. DSL management and/or Director will review and approve rules. The goal is to have this implemented in April 2024.
- Chris Gannon. Will RAC have a chance to review the Rule in its entirety? DSL's next step is to policy the rule with all proposed language. Then DSL will go out for public comments. DSL will notify all RAC members when public comment begins and where the proposed language can be found.
