



Unemployment Insurance payroll Paid Leave Oregon benefits and reporting begins small business assistance grants start Employers can apply for Paid Leave Oregon equivalent plans March 4, 2024 January 1, 2023 September 6, 2022 August 14, 2023 Employers and employees start paying Paid Leave Oregon contributions Quarterly Statewide Transit Tax and Paid Unemployment Insurance Leave Oregon contributions added to benefits begins combined payroll reporting


