- F. Public Comments Period (Information Item) This time is reserved for the public to address the Council regarding any item within Council jurisdiction that is not otherwise closed for comment. Applications for Site Certificates which are closed for comment include the Nolin Hills Wind Power Project and Boardman Hemingway Transmission Line Amendment #1.
- G. Nolin Hills Wind Power Project Proposed Order Review, Proposed Contested Case Order Review, Exceptions Hearing, Possible Material Change Hearing and Public Notice of Possible Hearing to Adopt Final Order (ORS 469.370(7)) (Information Item, Action Item & Working Lunch)

- 1.a <u>Proposed Order Review</u> Council will initiate review the proposed facility and procedural history of the application for site certificate. Council will review standards from the Proposed Order which were not part of the contested case proceeding and conduct a straw poll to preliminarily determine whether to affirm, reject or modify the findings of facts, conclusions of law and conditions of approval from the Proposed Order.
- 2. Overview of Contested Case, Proposed Contested Case Order, Filed Exceptions on the Proposed Contested Case Order and Responses to Filed Exceptions on the Proposed Contested Case Order
- 3. <u>Exceptions Hearing</u> Umatilla County will be allowed time to summarize or highlight points from their written exceptions based on the groupings below. Nolin Hills Wind, LLC (applicant) and the Oregon Department of Energy will be allowed time to provide oral comment in response. All oral comments will be subject to time limits established by the Council. Council will conduct a straw poll on each grouping to either affirm, reject or modify the findings of facts, conclusions of law or conditions of approval from the Hearing Officer's Proposed Contested Case Order.

The exceptions will be presented to Council as they are phrased by Umatilla County. The following is a summary of the topics raised in the exceptions and the order in which they will be addressed.

- Exception B.iv Whether the Hearing Officer decided, in the Order on party status and issues to be addressed in the contested case, that Council does not have authority to assess whether Criterion (3) is an applicable substantive criteria and whether that statement had to be appealed, under an appeal process that has already passed.
- Exceptions B.ii and B.iii Interpretation of "applicable substantive criteria" and whether the 2-mile setback meets the definition.
- Exceptions A.i, A.ii; B.v, B.i, B.vii and B.vi Whether the UEC Cottonwood transmission line is a related or supporting facility that crosses more than 3 zones, and dependent on the answer, whether Council has the authority to review under ORS 469.504(5).
- **1.b** Proposed Order Review Continuation of Council's review of Proposed Order for the Land Use standard.
- 4. <u>Possible Material Change Hearing</u> If based on the straw polls referenced above the Council proposes material changes to either the Proposed Order or Proposed Contested Case Order findings of facts, conclusions of law or conditions of approval, each party to the contested case will be allowed time to comment on each proposed material change. A change is material if it requires additional findings or conditions and/or are significant.
- 5. <u>Possible Hearing to Adopt Final Order (ORS 469.370(7))</u> Council will consider the oral testimony from the Material Change Hearing (if there is one) and issue a Final Order, either

approving or rejecting the application based upon the standards adopted under ORS 469.501 and any additional statutes, rules or local ordinances determined to be applicable to the facility by the project order, as amended. ORS 469.370 (7) and ORS 469.370 (9).

6. Boardman to Hemingway Transmission Line, Possible EFSC Review of Draft Proposed Order on Amendment 1 – Kellen Tardaewether, Senior Siting Analyst, will provide a presentation of the Draft Proposed Order (DPO) on Request for Amendment #1 for the Boardman to Hemingway Transmission line, an approved facility that includes approximate 300 miles (275 in Oregon) of electrical transmission line (primarily 500 kilovolt [kV]) that crosses 5 counties in Oregon; Morrow, Umatilla, Union, Baker and Malheur counties. The certificate holder is Idaho Power Corporation. Unless the record is extended, as approved by Council, the presentation will include an overview of standards, recommended amended conditions of approval, issues raised in comments received on the record of the DPO, and certificate holder responses for Council review. Council will have the opportunity to provide comments to the Department for consideration in the Proposed Order.
