Introduction: The Oregon Department of Energy (ODOE), staff to the Energy Facility Siting Council, received Request for Amendment 3 (RFA3) to transfer certificate holder ownership of the Shepherds Flat North Site Certificate from Caithness Energy, LLC to BEP SF Holdings, LLC. North Hurlburt Wind, LLC would remain as the certificate holder.

Description of the Facility: Shepherds Flat North (facility) is a 265 megawatt (MW) operating wind energy generation facility with 106 wind turbines. The facility is located within a site boundary of approximately 9,264 acres in Gilliam county. Related or supporting facilities include a power collection system, meteorological towers, field workshop, a collector substation, access roads, and temporary construction areas.

Facility Location: The facility is located south of Interstate Highway 84 and east of Arlington, in Gilliam County. A map of the facility site boundary is included in this notice or visit our online mapping tool at <u>https://tinyurl.com/EFSCmap.</u>

Site Certificate Transfer Process: To approve a Request for Amendment to Transfer, EFSC must find that the proposed new certificate holder owner, BEP SF Holdings, Inc, complies with the Council's Organizational Expertise (OAR 345-0220010) and Retirement and Financial Assurance (OAR 345-022-0050) standards.

ODOE will provide recommended findings of facts regarding compliance with the above standards, including an evaluation of any comments received prior to the transfer hearing, in a staff report to Council at least 14 days prior to the transfer hearing. The staff report, to include a draft Final Order, will be available on the Council's webpage and the Department's project webpage.

Prior to Council's review of the draft Final Order, Council will hold a transfer hearing. The transfer hearing is not a contested case hearing. At the conclusion of the transfer hearing, the Council will review the draft Final Order and take action to either approve or deny the final order; and, will either issue or deny issuance of an amended site certificate.

Transfer Hearing and Comment Period: A Transfer Hearing is anticipated to be held at 9:30 a.m. on Friday, February 26, 2021 during the Council's regularly scheduled meeting but could occur at a later date; WebEx details and physical address, if in-person option is available, will be provided via the Department's project webpage at least 14 days prior to the transfer hearing and will also be noticed via Council agenda.

Written comments are due no later than the close of the Transfer Hearing. Department staff will be available to answer questions related to the EFSC transfer process and the facility. Written or oral comments may be submitted prior to the transfer hearing by mail, e-mail, handdelivery or fax. Please send comments to:




Figure 1: Shepherds Flat North – Regional Location/Facility Site Boundary
