## Leaning Juniper IIA Wind Power Facility

Request for Comments on Request for Amendment 3 and Draft Proposed Order

- Repower 36 existing wind turbines
- Temporarily disturb approximately 396.2 acres of high-value farmland within a proposed micrositing corridor
- Install a new underground 34.5 kV collector system
- Decommission two turbines
- New conditions

Facility Location: Gilliam County, Oregon southwest of Arlington.

#### Amendment Review Type: Type A

<u>Recommendation</u>: The Oregon Department of Energy (ODOE or Department) recommends that the changes proposed in Request for Amendment 3 (RFA3 or amendment request) comply with all required standards and should be approved by the Energy Facility Siting Council (EFSC or Council).

Public Comment Period: February 29 through March 29, 2024.

**Description of Facility (approved):** The Leaning Juniper IIA Wind Power Facility is an operational 90.3 megawatt (MW) wind energy generation facility, located within a site boundary of 6,404 acres. The facility consists of 43 wind turbines, with a maximum blade tip height of 492 feet.

#### Description of Changes Proposed in RFA3: RFA3

seeks Council approval for the following changes to the site certificate, all of which to occur within the previously approved site boundary and micrositing corridor:

- Repower 36 wind turbines (replacement of rotors, nacelles and generator; and foundation reinforcement); increase blade tip height from 404 to 453 feet.
- Temporarily disturb approximately 396.2 acres of high-value farmland (roads, collector line, turbine pad, laydown and crane assembly areas) within a proposed micrositing corridor.
- Install a new underground, 34.5 kilovolt collector line system
- Decommission two wind turbines
- New conditions (see RFA3 Attachment 1 Section VII)

Facility Location (approved): Gilliam County, southwest of Arlington and west of Highway 19. A map of the site boundary is included in this notice. #### **EFSC Review Process:**

EFSC review is a consolidated, comprehensive permitting process. The certificate holder must demonstrate that the proposed amendment meets all applicable EFSC standards established under Oregon Revised Statute (ORS) 469.501 and set forth in Oregon Administrative Rule (OAR).

#### Leaning Juniper IIA Wind Power Facility Request for Amendment 3 Process Overview:

#### Request for Site Certificate Amendment

Leaning Juniper Wind Power II, LLC, a wholly owned subsidiary of Avangrid Renewables, LLC, the U.S. division of parent company Iberdrola, S.A. (certificate holder) filed preliminary Request for Amendment 3 (pRFA3) on September 23, 2023. Based on the Department's review of pRFA3 and responses to its requests for additional information received, the Department notified the certificate holder that the amendment request was complete on February 9, 2024. A complete amendment request was received on February 14, 2024. RFA3 is available on the project webpage for review, as described in the <u>More Information</u> section below.

#### Draft Proposed Order Issuance

On February 29, 2024, the Department issued a Draft Proposed Order (DPO) on RFA3. The DPO, ODOE's first evaluation for the amendment request, includes recommended findings of fact, conclusions of law and recommends new and amended site certificate conditions, all of which are open for the public to comment on. The DPO recommends that Council approve the changes proposed in the amendment request. The DPO is not a final order. The purpose of this DPO notice is to inform the public of an open comment period and a public hearing, with opportunities for in-person and remote participation.

#### Public Hearing and Comment Period

EFSC will hold the public hearing on RFA3 and the DPO on March 21, 2024 which will be both in person and remote. See in person meeting details and WebEx login information on page 1 of this notice for more details. The hearing will be conducted by EFSC.

During the hearing, there will first be a brief overview by ODOE on the siting process, approved

facility and requested amendment, followed by an overview of the hearing format and finally an opportunity to provide oral comments on RFA3 and the DPO.

To raise an issue on the record of the public hearing, a person must raise an issue either in person at the public hearing, or in a written comment submitted after the date of this notice of the public hearing and received by ODOE before the record closes on March 29, 2024, unless extended by Council.

A person's failure to raise an issue in person or in writing on the record of the public hearing precludes the Council's consideration of whether to grant that person's subsequent contested case request.

Failure to raise an issue in person or in writing prior to the close of the record of the public hearing with sufficient specificity to afford the decision maker (EFSC), the Department, and certificate holder an opportunity to respond to the issue precludes the Council from considering whether that issue justifies a contested case proceeding. To raise an issue with sufficient specificity, a person must present facts that support the person's position on the issue.

Written comments to be included on the record of the public hearing must be received by the comment deadline, either at the hearing, ODOE's online comment portal described below or by mail, email or fax to:

Written or oral comments may be hand-delivered, submitted verbally via Webinar/teleconference or inperson at the public hearing, or via electronic methods previously described. EFSC will not accept or consider comments on RFA3 or the DPO on RFA3 after the public comment deadline of March 29, 2024.

#### Online Comment Portal

ODOE has an online portal for submitting comments on projects. The goal of the online comment portal is to provide members of the public with another convenient option to submit input on projects, and to provide additional resources that will enable meaningful participation in the EFSC process.

To get started, choose a project from the drop-down menu. Only projects that have a comment period which is currently active will be listed. Choose your project, click "Next", and follow the instructions on the screen. You will receive an email confirmation after submitting your comment.

ODOE also has a new docket system available which displays comments that have been submitted on EFSC Siting projects. Comments for this project will be posted to the docket and will normally be available to view within 3 business days of receipt. #### Council Review of the Draft Proposed Order

Following the close of the record of the public hearing on the DPO, and during a Council meeting, EFSC will review the DPO, comments received on the record of the DPO and provide any comments they have to ODOE.

#### Proposed Order

After EFSC has reviewed the DPO and considered all comments received on the record of the public hearing as described in this notice, ODOE will issue a Proposed Order. ODOE will evaluate the comments received on the record of the DPO, certificate holder responses, as well as comments from EFSC, and make any necessary changes to the Department's recommended findings of fact, conclusions of law and conditions. These will be reflected in the Proposed Order, ODOE's second evaluation of whether the changes proposed in RFA3 comply with the applicable requirements. The Proposed Order shall recommend approval, modification, or denial of the first amended site certificate.

#### Contested Case

Along with the issuance of the Proposed Order, ODOE will issue a notice of an opportunity to request a contested case to all persons who commented on the record of the DPO public hearing. To be eligible to participate in a Contested Case proceeding, a person must raise an issue either in person at the public hearing or in a written comment submitted between February 29 and March 29, 2024, the date the record closes, unless extended. Contested case requests must be submitted in writing to ODOE by a deadline that will be specified within that notice.

To properly raise an issue in a request for a contested case proceeding, the issue must be within the jurisdiction of EFSC and must be raised with sufficient specificity to afford EFSC, the Department and the certificate holder an opportunity to respond to the issue. The issue must raise a significant issue of fact or law that is reasonably likely to affect EFSC's determination that the facility, with the changes proposed in the amendment request, meets applicable laws and EFSC standards included in OAR Chapter 345 Divisions 22, 23, and 24. Under the Scope of Council's Review for RFA3, Council must determine whether the preponderance of evidence on the record supports the conclusion that the facility, with the proposed change, complies with the applicable laws or Council standards that protect a resource or interest that could be affected by the proposed change; and the amount of the bond or letter of credit required under OAR 345-022-0050 is adequate. #### Final Order

Following the contested case proceeding, or the Proposed Order phase if no requests for a contested case are received and granted by EFSC, EFSC will issue a Final Order either approving or rejecting RFA3. If approved, an Amended Site Certificate will be issued.
