OAR 345-021-0010(1)(f) A list of the names and mailing addresses of property owners, as described in this subsection:

- (A) The list must include all owners of record, as shown on the most recent property tax assessment roll, of property located:
 - (i) Within 100 feet of property which is the subject of the application, where the subject property is wholly or in part within an urban growth boundary;
 - (ii) Within 250 feet of the property which is the subject of the application, where the subject property is outside an urban growth boundary and not within a farm or forest zone: or
 - (iii) Within 500 feet of the property which is the subject of the application, where the property is within a farm or forest zone;
- (B) The applicant must submit an updated list of property owners as requested by the Department before the Department issues notice of any public hearing on the application for a site certificate as described in OAR 345-015-0220; and
- (C) In addition to incorporating the list in the application, the applicant must submit the list to the Department in an electronic format approved by the Department.

F.1 PROPERTY OWNER NOTIFICATION

Response: OAR 345-001-0010(55) defines "site boundary" as "the perimeter of the site of a proposed energy facility, its related or supporting facilities, all temporary laydown and staging areas and all corridors and micrositing corridors proposed by the applicant." Under this definition, the site boundary is the perimeter of the Madras Solar Energy Facility (Facility) property, which covers approximately 284 acres and encompasses the solar modules, 34.5-kilovolt collector lines, power conversion stations, Facility substation, point of interconnection switching station, operations and maintenance enclosure, service roads, and security fencing and gates. Construction and laydown areas will also be located within the Facility site boundary, as will the temporary concrete batch plant, if needed.

The entire area within and surrounding the Facility site boundary is zoned exclusive farm use by Jefferson County. Pursuant to OAR 345-021-0010(1)(f)(A)(iii), property owner notification is required within 500 feet of the properties crossed by the Facility site boundary. Owing to the large size of surrounding parcels in the farm zone, Madras PV1, LLC (Applicant) has elected to notify property owners out to 1,000 feet from the properties crossed by the Facility site boundary to further public awareness and provide opportunity to comment.

OAR 345-021-0010(1)(f)(A)(i) and (ii) are not applicable to the Facility.


