**Proposed Order**

Pursuant to ORS 675.715 to 675.835 and OAR 833-001-0001 to 833-060-0001, the State Board of Licensed Professional Counselors and Therapists proposes to reject the application of Judith A. Augsburger (Applicant) to obtain a license as a professional counselor and to close the application file on the facts set forth herein and incorporated by reference. This action is being proposed because the Applicant failed to document meeting the experience standards for licensure within the time period allowed for application.

**Right to a Hearing**

The applicant, Judith A. Augsburger, has the right to a hearing under the provisions of the Administrative Procedures Act, ORS Chapter 183. Unless a hearing is requested in writing addressed to the Administrator, Board of Licensed Professional Counselors and Therapists, 3218 Pringle Road SE #160, Salem, Oregon 97302-6312 and is received on or before the close of business within 60 days from service by certified mail, or approximately July 3, 1998, the Board will adopt this order as its final order without further action. If a hearing is requested, you may be represented by counsel at the hearing. Attached is information on the procedures, right of representation, and the rights of parties relating to conduct of the hearing as required under ORS 183.413(2).

**Waiver**

If you request a hearing but fail to appear at the scheduled hearing, the Board may issue a final order by default denying you a license. By failing to request a hearing or appear at a hearing, Applicant waives any statutory requirements as to the form of the order including Findings of Fact and Conclusions of Law under the provisions of ORS 183.470.

**Facts and Statements in Support of Order**

1. Application for licensure signed by Applicant was received approximately 1/11/96.
2. Applicant was allowed two years to complete the application, until 1/11/98, by OAR 833-020-0020. Applicant requested no extensions. Two years have passed. To become licensed, Applicant must re-apply.

3. ORS 675.715(3) as defined by OAR 833-020-0050 and 833-020-0080, requires the applicant to document three years of full-time supervised work experience, no less than 2,400 client contact hours of counseling experience meeting standards for supervision. The applicant documented 280 hours from the clinical portion of the degree program that met the standards. The remainder of the hours submitted for review did not indicate compliance with the supervision standards:


A. Pamela Stockton attested to only two years of clinically supervised post-degree experience and listed 10 days of supervision training but did not give a date or actual clock hours.

B. Jane Weede attested, as employer, to the same hours as Ms. Stockton. Listing the same graduation date, license, and supervision training as well as only two years of clinically supervised post-degree experience. The supervision training came mid-way during the supervision period.

4. The Board of Licensed Professional Counselors and Therapists' application file and the documents therein relating to work experience are incorporated by reference in support of this order in the form the file existed on date.


