



2. ORS 675.715(2) requires applicant to hold graduate degree in counseling from a CACREP approved program, a degree determined to meet comparable standards adopted by the Board, or a degree program determined to meet a majority of the standards adopted by the Board as long as the applicant can document completion of all the coursework required by the standards. Applicant documented a degree from a program that met a majority of standards, but did not document all coursework required: 4.25 semester hours of graduate training including at least two semester credit hours in the area of appraisal and at least two semester credit hours in the area of social and cultural foundations.
3. ORS 675.715(3) as defined by OAR 833-020-0050 requires applicant to document three years of full-time supervised work experience, no less than 2,400 client contact hours of counseling meeting standards for supervision that include a supervisor with at least 30 clock hours of post-master's training in clinical supervision. Attestations of supervised work experience filed by Jack Kelley and Gary Oberg totaled only 1,300 hours and neither supervisor listed 30 hours of training in supervision.
4. OAR 833-020-0020 requires applicants who fail to become licensed within two years to reapply. Two years from application was July 18, 1998.
5. The Board of Licensed Professional Counselors and Therapists' application file and the documents therein are incorporated by reference in support of this order in the form the file existed on August 28, 1998.
