STIPULATED
FINAL ORDER

Pursuant to ORS 675.745 and 675.755, continuation of licensure came before the Board of Licensed Professional Counselors and Therapists (Board) as a result of an updated, corrected professional disclosure statement not being filed with the Board as required by OAR 833-50-010 and 833-50-020.

Pursuant to ORS 183.415(5) and OAR 833-50-030, in order to informally dispose of and settle this matter by this stipulated final order (the "Stipulation"), Janice L. Hindman (Licensee) and the Board by and through its Administrator make the following statements:

1.

Licensee admits and stipulates that she has been advised of her right to a hearing in this matter pursuant to ORS 183.415(2)(a) and to be represented by counsel that hearing pursuant to ORS 183.415(3).

2.

Licensee waives her right to such a hearing and waives the right to be represented by an attorney at such a hearing.

3.

Licensee waives any and all civil claims or actions against the Board relating to this issue.

4.

The Board and Licensee stipulate to the following: That the Board has jurisdiction, and the right to suspend or revoke a license if the Board were to prove that a licensee violated either the licensure statute or one or more of the rules of the Board, specifically ORS 675.745(1)(e), and ORS 675.755 (5), OAR 833-50-010 and 833-50-020.

5.

The Board and Licensee agree that this matter may be concluded by the entry of this Stipulation on the following terms:

(A) Licensee agrees to, and submits, an attached written explanation as to why an updated professional disclosure statement was not filed with the Board in a timely manner, or what steps were taken to comply with the Board's request for an updated professional disclosure statement.

(B) Licensee agrees to, and provides, an attached corrected, updated professional disclosure statement for all places of practices (or one for each place of practice) that meets the requirements for Board approval.

(C) Licensee agrees to pay, and submits, an attached check or money order in the amount of \$100 made payable to the Board of Counselors & Therapists as a settlement fee; and

(D) The Board, upon receipt and approval of the above, withdraws its proposed order, taking no disciplinary action in this case.


