Effective Date

Unless a hearing is requested in writing addressed to the Administrator, Board of Licensed Professional Counselors and Therapists, 796 Winter Street, NE, Salem, OR 97310, and is received on or before close of business within 60 days or January 3, 1994 or a stipulated agreement is effected on or prior to that date, this order becomes a final order without further action.

Proposed and Final Order

The professional counselor license (C0604) of Morris L LeMay is suspended based upon the facts set forth herein and incorporated by reference.

Right to a Hearing

The licensee, Morris L LeMay, has the right to request a hearing under the provisions of ORS chapter 183. If a hearing is requested, information on the procedures, right of representation and the rights of parties will be given before the commencement of the hearing.

Waiver

If no hearing is requested, Morris L LeMay, waives any statutory requirements as to the form of the order including Findings of Fact and Conclusions of Law under the provisions of ORS 183.470.

Facts and Statements of Violations in Support of Order

1. The Board has the right to suspend a license issued under ORS 675.715 to 675.835 upon proof the licensee has violated one or more of the rules of the board (ORS 675.745(1)(d)).


2. The licensee failed to document meeting the continuing education requirements pursuant to OAR 833-25-060 (3) and (4).

3. On or about June 14, 1993, licensee was notified of audit and given 20 days in which to submit documentation to provide proof that the continuing education claimed for license year 1992-93 (April 1 through April 1) was completed and met the criteria established by OAR 833-25-050.

4. The Board received no response to its request for documentation to support the hours claimed on the continuing education report; nor was the envelope returned as undeliverable.

5. The Board of Licensed Professional Counselors and Therapists file and the documents therein are incorporated by reference in support of this order in the form as it existed on August 27, 1993.
