FINAL ORDER BY DEFAULT

On or about September 17, 1997, the State Board of Licensed Professional Counselors and Therapists served notice stating that the Board intended to suspend the professional counselor license, number C0788, of Pauline E Pahle (Licensee) by certified mail addressed to the last known address filed by Pauline E Pahle with the Board. The notice alleged that Licensee failed to comply with agreed upon conditions that resulted in a continuing education waiver granted by the Board for renewal April 1, 1997. The notice further granted Licensee an opportunity for hearing, setting the time and place at 10:00 am, October 24, 1997 in Salem, Oregon. Neither Licensee nor an attorney representing Licensee appeared before the Board at the scheduled time and place.

NOW THEREFORE, after consideration of the records and files of the board relating to this matter, the Board enters the following Order.

Findings of Fact

1. Licensee was granted a continuing education waiver on condition Licensee complete and document 12 hours of continuing education by July 31, 1997.
2. Licensee was granted a extension of time, to August 15, 1997, to complete and document compliance with the agreement.
3. Licensee was warned that failure to comply could result in compliance action.
4. Licensee submitted no documentation to confirm completion of the 12 hours of continuing education by September 15, 1997.

Ultimate Findings of Fact

Licensee did not complete the continuing education hours required as a condition for receiving a continuing education waiver that allowed Licensee to renew her license a professional counselor April 1, 1997.

Conclusions of Law


1. Licensee violated ORS 675.725(2)(b) by failing to provide proof of fulfillment of any board requirements for continuing education.
2. Licensee violated OAR 833-025-0050 by failing to complete 20 clock hours of continuing education as a condition of renewal and as approved for waiver/extension based on medical condition.
3. Licensee violated OAR 833-025-0060(4) by failing to document required hours.

Order

The professional counselor license of Pauline E. Pahle is suspended and she may no longer practice counseling under the title "licensed professional counselor" or indicate to the public that she possesses a valid license.
